Mr. JOHNSON of Ohio (for himself and Mr. TONKO) introduced the following bill; which was referred to the Committee on Energy and Commerce

A BILL

To reauthorize the United States Anti-Doping Agency, and
for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “United States Anti-
5 Doping Agency Reauthorization Act”.

6 **SEC. 2. PROHIBIT PERFORMANCE-ENHANCING METHODS.**

7 Section 701 of title VII of the Office of National
8 Drug Control Policy Reauthorization Act of 2006 (21
9 U.S.C. 2001) is amended—

10 (1) in subsection (a), by striking paragraph (4);

11 and

1 (2) in subsection (b)—

2 (A) in paragraph (1), by inserting “and be
3 recognized worldwide as the independent na-
4 tional anti-doping organization for the United
5 States” after “Committee”;

6 (B) in paragraph (2), by striking “, or per-
7 formance-enhancing genetic modifications ac-
8 complished through gene-doping” and inserting
9 “or prohibited performance-enhancing methods
10 adopted by the Agency”;

11 (C) in paragraph (3), by striking “, or per-
12 formance-enhancing genetic modifications ac-
13 complished through gene-doping” and inserting
14 “or prohibited performance-enhancing methods
15 adopted by the Agency”;

16 (D) in paragraph (4), by striking “and the
17 prevention of use of performance-enhancing
18 drugs, or performance-enhancing genetic modi-
19 fications accomplished through gene-doping by
20 United States amateur athletes; and” and in-
21 serting “, and the prevention of use by United
22 States amateur athletes of performance-enhanc-
23 ing drugs or prohibited performance-enhancing
24 methods adopted by the Agency.”; and

25 (E) by striking paragraph (5).

1 **SEC. 3. AUTHORIZATION OF APPROPRIATIONS.**

2 Section 703 of title VII of the Office of National
3 Drug Control Policy Reauthorization Act of 2006 (21
4 U.S.C. 2003) is amended to read as follows:

5 **“SEC. 703. AUTHORIZATION OF APPROPRIATIONS.**

6 “There are authorized to be appropriated to the
7 United States Anti-Doping Agency—

8 “(1) for fiscal year 2014, \$11,300,000;

9 “(2) for fiscal year 2015, \$11,700,000;

10 “(3) for fiscal year 2016, \$12,300,000;

11 “(4) for fiscal year 2017, \$12,900,000;

12 “(5) for fiscal year 2018, \$13,500,000;

13 “(6) for fiscal year 2019, \$14,100,000; and

14 “(7) for fiscal year 2020, \$14,800,000.”.
