To award a Congressional Gold Medal in recognition of Alice Paul's role in the women's suffrage movement and in advancing equal rights for women.

Mr. RUNYAN introduced the following bill; which was referred to the Committee on Financial Services

A BILL

To award a Congressional Gold Medal in recognition of Alice Paul's role in the women's suffrage movement and in advancing equal rights for women.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the "Alice Paul Women's
5 Suffrage Congressional Gold Medal Act".

6 **SEC. 2. FINDINGS.**

7 The Congress finds as follows:

8 (1) Alice Paul was born on January, 11, 1885,
9 in Mount Laurel, New Jersey, and died on July 9,
10 1977.

1 (2) Alice Paul dedicated her life to securing suf-
2 frage and equal rights for all women and, as founder
3 of the World Woman’s Party, she was instrumental
4 in the passage of the 19th Amendment to the United
5 States Constitution.

6 (3) Alice Paul and the National Woman’s Party
7 were the first group ever to picket the White House.

8 (4) While President Woodrow Wilson trumpeted
9 America’s values of democracy abroad during World
10 War I, Alice Paul was dedicated to reminding the
11 President that not all Americans enjoyed democracy
12 at home.

13 (5) Alice Paul used nonviolent civil disobedience
14 to bring national attention to the women’s suffrage
15 movement, such as the 3-week hunger strike she un-
16 dertook when she was sentenced to jail in October,
17 1917, for her demonstrations.

18 (6) Alice Paul’s courage inspired thousands of
19 women to join the women’s suffrage movement.

20 (7) Instead of patiently waiting for States to
21 grant women suffrage, Alice Paul mobilized an en-
22 tire generation of women to pressure the United
23 States Congress and the President to give all women
24 in America the right to vote.

1 (8) Alice Paul did not stop her fight after the
2 19th Amendment was ratified; she drafted the Equal
3 Rights Amendment to the United States Constitu-
4 tion in 1923 and fought tirelessly for its passage
5 until her death 54 years later.

6 (9) Alice Paul lobbied Congress to include gen-
7 der in civil rights bills and was successful in includ-
8 ing sex discrimination in Title VII of the Civil
9 Rights Act of 1964.

10 (10) Alice Paul sought equal rights for women
11 all over the world, not just Americans and, as a
12 means of pursuing this goal, founded the World
13 Party for Equal Rights for Women in the 1930s.

14 (11) Alice Paul was instrumental in the place-
15 ment of a passage on gender equality in the pre-
16 amble of the United Nations Charter.

17 (12) Few people have played a greater role in
18 shaping the history of the United States than Alice
19 Paul.

20 (13) Alice Paul is an example to all Americans
21 of what one person can do to make a difference for
22 millions of people.

23 **SEC. 3. CONGRESSIONAL GOLD MEDAL.**

24 (a) PRESENTATION AUTHORIZED.—The Speaker of
25 the House of Representatives and the President pro tem-

1 pore of the Senate shall make appropriate arrangements
2 for the presentation, on behalf of the Congress, of a gold
3 medal of appropriate design in commemoration of Alice
4 Paul, in recognition of her role in the women's suffrage
5 movement and in advancing equal rights for women.

6 (b) PRESENTATION AND DISPLAY.—The medal re-
7 ferred to in subsection (a) shall be presented jointly to
8 representatives of the Alice Paul Institute and the Sewall-
9 Belmont House, to be shared equally and displayed as ap-
10 propriate.

11 (c) DESIGN AND STRIKING.—For purposes of the
12 presentation referred to in subsection (a), the Secretary
13 of the Treasury (hereafter in this Act referred to as the
14 “Secretary”) shall strike a gold medal with suitable em-
15 blems, devices, and inscriptions, to be determined by the
16 Secretary.

17 **SEC. 4. DUPLICATE MEDALS.**

18 The Secretary may strike and sell duplicates in
19 bronze of the gold medal struck pursuant to section 3
20 under such regulations as the Secretary may prescribe, at
21 a price sufficient to cover the cost thereof, including labor,
22 materials, dies, use of machinery, and overhead expenses,
23 and the cost of the gold medal.

1 **SEC. 5. STATUS OF MEDALS.**

2 (a) NATIONAL MEDALS.—The medals struck pursu-
3 ant to this Act are national medals for purposes of chapter
4 51 of title 31, United States Code.

5 (b) NUMISMATIC ITEMS.—For purposes of section
6 5134 of title 31, United States Code, all medals struck
7 under this Act shall be considered to be numismatic items.

8 **SEC. 6. AUTHORITY TO USE FUND AMOUNTS; PROCEEDS OF**
9 **SALE.**

10 (a) AUTHORITY TO USE FUND AMOUNTS.—There is
11 authorized to be charged against the United States Mint
12 Public Enterprise Fund, such amounts as may be nec-
13 essary to pay for the costs of the medals struck pursuant
14 to this Act.

15 (b) PROCEEDS OF SALE.—Amounts received from the
16 sale of duplicate bronze medals authorized under section
17 4 shall be deposited into the United States Mint Public
18 Enterprise Fund.
