Mr. BOUSTANY (for himself, Mr. PIERLUISI, Ms. HANABUSA, Mr. SMITH of New Jersey, and Ms. DELAURO) introduced the following bill; which was referred to the Committee on Veterans' Affairs

A BILL

To authorize certain Department of Veterans Affairs major medical facility leases, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Keep Our Commitment
5 to Veterans Act”.

6 **SEC. 2. AUTHORIZATION OF FISCAL YEARS 2013 AND 2014**

7 **MAJOR MEDICAL FACILITY LEASES.**

8 The Secretary of Veterans Affairs may carry out the
9 following major medical facility leases in fiscal years 2013
10 and 2014 at the locations specified:

1 (1) A clinical research and pharmacy coordi-
2 nating center, Albuquerque, New Mexico.

3 (2) A community based outpatient clinic, Brick,
4 New Jersey.

5 (3) A new primary care and dental clinic annex,
6 Charleston, South Carolina.

7 (4) The Cobb County Community Based Out-
8 patient Clinic, Cobb County, Georgia.

9 (5) The Leeward Outpatient Healthcare Access
10 Center, Honolulu, Hawaii, including a co-located
11 clinic with the Department of Defense and the co-
12 location of the Honolulu Regional Office of the Vet-
13 erans Benefits Administration and the Kapolei Vet
14 Center of the Department of Veterans Affairs.

15 (6) A community based outpatient clinic, Lafay-
16 ette, Louisiana.

17 (7) A community based outpatient clinic, Lake
18 Charles, Louisiana.

19 (8) Outpatient clinic consolidation, New Port
20 Richey, Florida.

21 (9) An outpatient clinic, Ponce, Puerto Rico.

22 (10) Lease consolidation, San Antonio, Texas.

23 (11) The Errera Community Care Center, West
24 Haven, Connecticut.

1 (12) The Worchester Community Based Out-
2 patient Clinic, Worchester, Massachusetts.

3 **SEC. 3. AUTHORIZATION IN REDUCED AMOUNTS FOR**
4 **MAJOR FACILITY LEASES PREVIOUSLY AU-**
5 **THORIZED IN PRIOR FISCAL YEARS.**

6 The Secretary of Veterans Affairs may carry out the
7 following major medical facility leases in fiscal year 2013
8 at the locations specified, in an amount for each lease not
9 to exceed the amount shown for such location:

10 (1) For a community based outpatient clinic,
11 Johnson County, Kansas, authorized by section
12 1(a)(9) of the Act entitled “An Act to authorize
13 major medical facility leases for the Department of
14 Veterans Affairs for fiscal year 2010, and for other
15 purposes.” (Public Law 111–82; 123 Stat. 2140),
16 an amount not to exceed \$2,431,900.

17 (2) For the expansion of a community based
18 outpatient clinic, San Diego, California, authorized
19 by section 901(3) of the Veterans’ Benefits Act of
20 2010 (Public Law 111–275; 124 Stat. 2894), an
21 amount not to exceed \$11,893,505.

22 (3) For the expansion of the community based
23 outpatient clinic, Tyler, Texas, authorized by section
24 7(a)(3) of the Veterans Programs Extension Act of

- 1 2006 (Public Law 109–444; 120 Stat. 3312), an
- 2 amount not to exceed \$3,610,775.
