A BILL

To improve Federal land management, resource conservation, environmental protection, and use of Federal real property, by requiring the Secretary of the Interior to develop a multipurpose cadastre of Federal real property and identifying inaccurate, duplicate, and out-of-date Federal land inventories, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Federal Land Asset In-*
5 *ventory Reform Act of 2014”.*

6 **SEC. 2. CADASTRE OF FEDERAL LAND.**

7 (a) *IN GENERAL.*—*The Secretary shall develop and*
8 *maintain a current and accurate a multipurpose cadastre*
9 *of Federal real property to support Federal land manage-*
10 *ment activities, including, but not limited to: resource de-*
11 *velopment and conservation, agricultural use, active forest*
12 *management, environmental protection, and use of real*
13 *property.*

14 (b) *COST-SHARING.*—*The Secretary may enter into*
15 *cost-sharing agreements with States to include any non-*
16 *Federal lands in a State in the cadastre. The Federal share*
17 *of any such cost agreement shall not exceed 50 percent of*
18 *the total cost to a State for the development of the cadastre*
19 *of non-Federal lands in the State.*

20 (c) *CONSOLIDATION AND REPORT.*—*Not later than 180*
21 *days after the date of the enactment of this Act, the Sec-*
22 *retary shall submit a report to the Committee on Natural*
23 *Resources of the House of Representatives and the Com-*
24 *mittee on Energy and Natural Resources of the Senate on—*

1 (1) *the existing real property inventories or any*
2 *components of any cadastre currently authorized by*
3 *law or conducted by the Department of the Interior,*
4 *the statutory authorization for such, and the amount*
5 *expended by the Federal Government for each such ac-*
6 *tivity in fiscal year 2012;*

7 (2) *the existing real property inventories or any*
8 *components of any cadastre currently authorized by*
9 *law or conducted by the Department of the Interior*
10 *that will be eliminated or consolidated into the multi-*
11 *purpose cadastre authorized by this Act;*

12 (3) *the existing real property inventories or any*
13 *components of a cadastre currently authorized by law*
14 *or conducted by the Department of the Interior that*
15 *will not be eliminated or consolidated into the multi-*
16 *purpose cadastre authorized by this Act, together with*
17 *a justification for not terminating or consolidating*
18 *such in the multipurpose cadastre authorized by this*
19 *Act;*

20 (4) *the use of existing real property inventories*
21 *or any components of any cadastre currently con-*
22 *ducted by any unit of State or local government that*
23 *can be used to identify Federal real property within*
24 *such unit of government;*

1 (5) *the cost-savings that will be achieved by*
2 *eliminating or consolidating duplicative or unneeded*
3 *real property inventories or any components of a ca-*
4 *dastre currently authorized by law or conducted by*
5 *the Department of the Interior that will become part*
6 *of the multipurpose cadastre authorized by this Act;*

7 (6) *in consultation with the Director of the Of-*
8 *fice of Management and Budget, the Administrator of*
9 *the General Services Administration, and the Comp-*
10 *troller General of the United States, conduct the as-*
11 *essment required by paragraphs (1) through (5) of*
12 *this subsection with regard to all cadastres and inven-*
13 *tories authorized, operated or maintained by all other*
14 *Executive agencies of the Federal Government; and*

15 (7) *recommendations for any legislation nec-*
16 *essary to increase the cost-savings and enhance the ef-*
17 *fectiveness and efficiency of replacing, eliminating, or*
18 *consolidating real property inventories or any compo-*
19 *nents of a cadastre currently authorized by law or*
20 *conducted by the Department of the Interior.*

21 (d) *COORDINATION.—*

22 (1) *IN GENERAL.—In carrying out this section,*
23 *the Secretary shall—*

24 (A) *participate, pursuant to section 216 of*
25 *Public Law 107–347, in the establishment of*

1 *such standards and common protocols as are*
2 *necessary to assure the interoperability of*
3 *geospatial information pertaining to the cadastre*
4 *for all users of such information;*

5 *(B) coordinate with, seek assistance and co-*
6 *operation of, and provide liaison to the Federal*
7 *Geographic Data Committee pursuant to Office*
8 *of Management and Budget Circular A-16 and*
9 *Executive Order 12906 for the implementation of*
10 *and compliance with such standards as may be*
11 *applicable to the cadastre;*

12 *(C) make the cadastre interoperable with*
13 *the Federal Real Property Profile established*
14 *pursuant to Executive Order 13327;*

15 *(D) integrate with and leverage to the max-*
16 *imum extent practicable current cadastre activi-*
17 *ties of units of State and local government; and*

18 *(E) use contracts with the private sector, to*
19 *the maximum extent practicable, to provide such*
20 *products and services as are necessary to develop*
21 *the cadastre.*

22 *(2) CONTRACTS CONSIDERED SURVEYING AND*
23 *MAPPING.—Contracts entered into under paragraph*
24 *(1)(E) shall be considered “surveying and mapping”*
25 *services as such term is used and as such contracts*

1 *are awarded in accordance with the selection proce-*
2 *dures in title IX of the Federal Property and Admin-*
3 *istrative Services Act of 1949 (40 U.S.C. 1101 et*
4 *seq.).*

5 **SEC. 3. DEFINITIONS.**

6 *As used in this Act, the following definitions apply:*

7 (1) *SECRETARY.*—*The term “Secretary” means*
8 *the Secretary of the Interior.*

9 (2) *CADASTRE.*—*The term “cadastre” means an*
10 *inventory of real property of the Federal Government*
11 *developed through collecting, storing, retrieving, or*
12 *disseminating graphical or digital data depicting*
13 *natural or man-made physical features, phenomena,*
14 *or boundaries of the earth and any information re-*
15 *lated thereto, including surveys, maps, charts, satellite*
16 *and airborne remote sensing data, images, and serv-*
17 *ices, with services performed by professionals such as*
18 *surveyors, photogrammetrists, hydrographers, geode-*
19 *sists, cartographers, and other such services of an ar-*
20 *chitectural or engineering nature including the fol-*
21 *lowing data layers:*

22 (A) *A reference frame consisting of a cur-*
23 *rent geodetic network.*

24 (B) *A series of current, accurate large scale*
25 *maps.*

1 (C) *An existing cadastral boundary overlay*
2 *delineating all cadastral parcels.*

3 (D) *A system for indexing and identifying*
4 *each cadastral parcel.*

5 (E) *A series of land data files, each includ-*
6 *ing the parcel identifier, which can be used to re-*
7 *trieve information and cross reference between*
8 *and among other data files, which contains in-*
9 *formation about the use, assets and infrastruc-*
10 *ture of each parcel, and shall also designate any*
11 *parcels that the Secretary determines can be bet-*
12 *ter managed through ownership by a non-Fed-*
13 *eral entity including but not limited to State*
14 *government, local government, Tribal govern-*
15 *ment, nonprofit organizations, or the private sec-*
16 *tor.*

17 (3) *REAL PROPERTY.—The term “real property”*
18 *means real estate consisting of land, buildings, crops,*
19 *forests, or other resources still attached to or within*
20 *the land or improvements or fixtures permanently at-*
21 *tached to the land or a structure on it, including any*
22 *interest, benefit, right, or privilege in such property.*

23 **SEC. 4. TRANSPARENCY AND PUBLIC ACCESS.**

24 *The Secretary shall—*

1 (1) *make the cadastre publically available on the*
2 *internet in a graphically geo-enabled and searchable*
3 *format;*

4 (2) *ensure that the inventory referred to in sec-*
5 *tion 2 includes the identification of all lands and*
6 *parcels suitable for disposal by Resource Management*
7 *Plans conducted for pursuant to the Federal Land*
8 *Policy and Management Act of 1976 (FLPMA, 43*
9 *U.S.C. 1711 et. seq.); and*

10 (3) *in consultation with the Secretary of Defense*
11 *and the Secretary of Homeland Security, prevent the*
12 *disclosure of any parcel or parcels of land, and build-*
13 *ings or facilities thereon, or information related there-*
14 *to, if such disclosure would impair or jeopardize the*
15 *national security or homeland defense of the United*
16 *States.*

17 **SEC. 5. RIGHT OF ACTION.**

18 *Nothing in this Act shall create any substantive or pro-*
19 *cedural right or benefit.*
