## RESOLUTION

Providing for consideration of the Senate amendment to the joint resolution (H.J. Res. 59) making continuing appropriations for fiscal year 2014, and for other purposes, and providing for consideration of the bill (H.R. 3210) making continuing appropriations for military pay in the event of a Government shutdown.

- 1       *Resolved*, That upon adoption of this resolution it
- 2 shall be in order to take from the Speaker's table the joint
- 3 resolution (H.J. Res. 59) making continuing appropria-

1 tions for fiscal year 2014, and for other purposes, with  
2 the Senate amendment thereto, and to consider in the  
3 House, without intervention of any point of order, a mo-  
4 tion offered by the chair of the Committee on Appropria-  
5 tions or his designee that the House concur in the Senate  
6 amendment with each of the two amendments printed in  
7 the report of the Committee on Rules accompanying this  
8 resolution. The Senate amendment and the motion shall  
9 be considered as read. The motion shall be debatable for  
10 one hour equally divided and controlled by the chair and  
11 ranking minority member of the Committee on Appropria-  
12 tions. The previous question shall be considered as ordered  
13 on the motion to its adoption without intervening motion  
14 or demand for division of the question except that the  
15 question of adoption of the motion shall be divided be-  
16 tween the two House amendments.

17       SEC. 2. Upon adoption of this resolution it shall be  
18 in order to consider in the House the bill (H.R. 3210)  
19 making continuing appropriations for military pay in the  
20 event of a Government shutdown. All points of order  
21 against consideration of the bill are waived. The bill shall  
22 be considered as read. All points of order against provi-  
23 sions in the bill are waived. The previous question shall  
24 be considered as ordered on the bill and on any amend-  
25 ment thereto to final passage without intervening motion

1 except: (1) 40 minutes of debate equally divided and con-  
2 trolled by the chair and ranking minority member of the  
3 Committee on Appropriations; and (2) one motion to re-  
4 commit.
