Mr. WARNER (for himself and Mr. Kaine) introduced the following bill; which was read twice and referred to the Committee on Energy and Natural Resources

A BILL

To provide for the inclusion of Lease Sale 220 in the outer Continental Shelf leasing program for fiscal years 2012–2017, to revise the map for the Mid-Atlantic planning area, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Virginia Outer Conti-
5 nental Shelf Energy Production Act of 2013”.

6 **SEC. 2. DEFINITIONS.**

7 In this Act:

1 (1) LEASE SALE 220.—The term “Lease Sale
2 220” means the sale of Federal oil, gas, wind, or al-
3 ternative and renewable energy exploration leases in
4 the outer Continental Shelf planning area located off
5 the coast of the State.

6 (2) QUALIFIED REVENUES.—The term “quali-
7 fied revenues” means all rentals, royalties, bonus
8 bids, and other sums due and payable to the United
9 States under a lease sale conducted under section
10 3(a)(1).

11 (3) SECRETARY.—The term “Secretary” means
12 the Secretary of the Interior.

13 (4) STATE.—The term “State” means the State
14 of Virginia.

15 **SEC. 3. OUTER CONTINENTAL SHELF ENERGY LEASES OFF**
16 **THE COAST OF THE STATE OF VIRGINIA.**

17 (a) AUTHORIZATION OF LEASE SALES.—In carrying
18 out the outer Continental Shelf leasing program for fiscal
19 years 2012–2017 prepared under section 18 of the Outer
20 Continental Shelf Lands Act (43 U.S.C. 1344), the Sec-
21 retary shall—

22 (1) include in the schedule of proposed lease
23 sales—

24 (A) Lease Sale 220; and

1 (B) any areas off the coast of the State
2 that are included in the Mid-Atlantic planning
3 area as a result of the revision to the map
4 under section 4(b); and

5 (2) provide that the Secretary shall not make
6 any tract available for lease under paragraph (1) if
7 the President, in consultation with the Committees
8 on Armed Services of the Senate and the House of
9 Representatives, determines that the lease of that
10 tract would conflict with military operations relating
11 to national security.

12 (b) DISPOSITION OF REVENUES.—

13 (1) IN GENERAL.—Notwithstanding section 9 of
14 the Outer Continental Shelf Lands Act (43 U.S.C.
15 1338) and subject to the provisions of this section,
16 for each applicable fiscal year, the Secretary of the
17 Treasury shall deposit—

18 (A) 50 percent of any qualified revenues in
19 the general fund of the Treasury; and

20 (B) 50 percent of any qualified revenues in
21 a special account in the Treasury to be used for
22 the purposes described in paragraph (2).

23 (2) DISPOSITION OF REVENUES TO STATE.—Of
24 the qualified revenues described in paragraph
25 (1)(B)—

1 (A) 75 percent shall be disbursed to the
2 State; and

3 (B) 25 percent shall be used, at the discre-
4 tion of the President—

5 (i) to enhance State land and water
6 conservation efforts;

7 (ii) to improve State public transpor-
8 tation projects; and

9 (iii) to establish State alternative and
10 renewable energy systems.

11 **SEC. 4. REVISED MAP OF THE MID-ATLANTIC PLANNING**
12 **AREA.**

13 (a) DEFINITION OF MID-ATLANTIC STATE.—In this
14 section, the term “Mid-Atlantic State” means each of the
15 States of Delaware, North Carolina, Maryland, and Vir-
16 ginia.

17 (b) REVISION OF MAP.—Subject to subsection (c),
18 the Secretary shall revise the Bureau of Ocean Energy
19 Management, Regulation and Enforcement map entitled
20 “Atlantic NAD 83 Federal Outer Continental Shelf (OCS)
21 Administrative Boundaries” and dated January 2010 to
22 ensure that the square footage of the leasable area in the
23 Mid-Atlantic planning area is directly proportional to the
24 length of the tidal shoreline of the Mid-Atlantic States,
25 as determined using the information on tidal shorelines

1 provided in the document published by the National Oce-
2 anic and Atmospheric Administration entitled “The Coast-
3 line of the United States” and numbered NOAA/PA
4 71046 (1975).

5 (c) LIMITATION.—Nothing in this section affects the
6 boundary of Lease Sale 220.
