Mr. REED (for himself, Ms. STABENOW, Mr. HARKIN, and Mr. WHITEHOUSE)
introduced the following bill; which was read twice and referred to the
Committee on Finance

A BILL

To provide for the extension of certain unemployment
benefits, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Emergency Unemploy-
5 ment Compensation Extension Act of 2013”.

6 **SEC. 2. EXTENSION OF EMERGENCY UNEMPLOYMENT COM-**
7 **PENSATION PROGRAM.**

8 (a) EXTENSION.—Section 4007(a)(2) of the Supple-
9 mental Appropriations Act, 2008 (Public Law 110–252;

1 26 U.S.C. 3304 note) is amended by striking “January
2 1, 2014” and inserting “January 1, 2015”.

3 (b) FUNDING.—Section 4004(e)(1) of the Supple-
4 mental Appropriations Act, 2008 (Public Law 110–252;
5 26 U.S.C. 3304 note) is amended—

6 (1) in subparagraph (I), by striking “and” at
7 the end;

8 (2) in subparagraph (J), by inserting “and” at
9 the end; and

10 (3) by inserting after subparagraph (J) the fol-
11 lowing:

12 “(K) the amendments made by section
13 2(a) of the Emergency Unemployment Com-
14 pensation Extension Act of 2013;”.

15 (c) EFFECTIVE DATE.—The amendments made by
16 this section shall take effect as if included in the enact-
17 ment of the American Taxpayer Relief Act of 2012 (Public
18 Law 112–240).

19 **SEC. 3. TEMPORARY EXTENSION OF EXTENDED BENEFIT**
20 **PROVISIONS.**

21 (a) IN GENERAL.—Section 2005 of the Assistance for
22 Unemployed Workers and Struggling Families Act, as
23 contained in Public Law 111–5 (26 U.S.C. 3304 note),
24 is amended—

1 (1) by striking “December 31, 2013” each
2 place it appears and inserting “December 31,
3 2014”; and

4 (2) in subsection (c), by striking “June 30,
5 2014” and inserting “June 30, 2015”.

6 (b) EXTENSION OF MATCHING FOR STATES WITH
7 NO WAITING WEEK.—Section 5 of the Unemployment
8 Compensation Extension Act of 2008 (Public Law 110–
9 449; 26 U.S.C. 3304 note) is amended by striking “June
10 30, 2014” and inserting “June 30, 2015”.

11 (c) EXTENSION OF MODIFICATION OF INDICATORS
12 UNDER THE EXTENDED BENEFIT PROGRAM.—Section
13 203 of the Federal-State Extended Unemployment Com-
14 pensation Act of 1970 (26 U.S.C. 3304 note) is amend-
15 ed—

16 (1) in subsection (d), by striking “December
17 31, 2013” and inserting “December 31, 2014”; and

18 (2) in subsection (f)(2), by striking “December
19 31, 2013” and inserting “December 31, 2014”.

20 (d) EFFECTIVE DATE.—The amendments made by
21 this section shall take effect as if included in the enact-
22 ment of the American Taxpayer Relief Act of 2012 (Public
23 Law 112–240).

1 **SEC. 4. EXTENSION OF FUNDING FOR REEMPLOYMENT**
 2 **SERVICES AND REEMPLOYMENT AND ELIGI-**
 3 **BILITY ASSESSMENT ACTIVITIES.**

4 (a) IN GENERAL.—Section 4004(c)(2)(A) of the Sup-
 5 plemental Appropriations Act, 2008 (Public Law 110–
 6 252; 26 U.S.C. 3304 note) is amended by striking
 7 “through fiscal year 2014” and inserting “through fiscal
 8 year 2015”.

9 (b) EFFECTIVE DATE.—The amendments made by
 10 this section shall take effect as if included in the enact-
 11 ment of the American Taxpayer Relief Act of 2012 (Public
 12 Law 112–240).

13 **SEC. 5. ADDITIONAL EXTENDED UNEMPLOYMENT BENE-**
 14 **FITS UNDER THE RAILROAD UNEMPLOY-**
 15 **MENT INSURANCE ACT.**

16 (a) EXTENSION.—Section 2(c)(2)(D)(iii) of the Rail-
 17 road Unemployment Insurance Act (45 U.S.C.
 18 352(c)(2)(D)(iii)) is amended—

19 (1) by striking “June 30, 2013” and inserting
 20 “June 30, 2014”; and

21 (2) by striking “December 31, 2013” and in-
 22 serting “December 31, 2014”.

23 (b) CLARIFICATION ON AUTHORITY TO USE
 24 FUNDS.—Funds appropriated under either the first or
 25 second sentence of clause (iv) of section 2(c)(2)(D) of the
 26 Railroad Unemployment Insurance Act shall be available

1 to cover the cost of additional extended unemployment
2 benefits provided under such section 2(c)(2)(D) by reason
3 of the amendments made by subsection (a) as well as to
4 cover the cost of such benefits provided under such section
5 2(c)(2)(D), as in effect on the day before the date of en-
6 actment of this Act.

7 (c) FUNDING FOR ADMINISTRATION.—Out of any
8 funds in the Treasury not otherwise appropriated, there
9 are appropriated to the Railroad Retirement Board
10 \$250,000 for administrative expenses associated with the
11 payment of additional extended unemployment benefits
12 provided under section 2(c)(2)(D) of the Railroad Unem-
13 ployment Insurance Act by reason of the amendments
14 made by subsection (a), to remain available until ex-
15 pended.
