A BILL

To repeal the Patient Protection and Affordable Care Act and the Health Care and Education Reconciliation Act of 2010 entirely.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “ObamaCare Repeal
3 Act”.

4 **SEC. 2. REPEAL OF THE PATIENT PROTECTION AND AF-**
5 **FORDABLE CARE ACT AND THE HEALTH**
6 **CARE AND EDUCATION RECONCILIATION ACT**
7 **OF 2010.**

8 (a) PATIENT PROTECTION AND AFFORDABLE CARE
9 ACT.—Effective as of the enactment of the Patient Pro-
10 tection and Affordable Care Act (Public Law 111–148),
11 such Act is repealed, and the provisions of law amended
12 or repealed by such Act are restored or revived as if such
13 Act had not been enacted.

14 (b) HEALTH CARE AND EDUCATION RECONCILI-
15 ATION ACT OF 2010.—Effective as of the enactment of
16 the Health Care and Education Reconciliation Act of 2010
17 (Public Law 111–152), such Act is repealed, and the pro-
18 visions of law amended or repealed by such Act are re-
19 stored or revived as if such Act had not been enacted.

20 **SEC. 3. BUDGETARY EFFECTS OF THIS ACT.**

21 The budgetary effects of this Act, for the purpose of
22 complying with the Statutory Pay-As-You-Go Act of 2010,
23 shall be determined by reference to the latest statement
24 titled “Budgetary Effects of PAYGO Legislation” for this
25 Act, submitted for printing in the Congressional Record
26 by the Chairman of the Committee on the Budget of the

- 2 been submitted prior to the vote on passage of this Act.
