A BILL

To rename the Government Printing Office the Government
Publishing Office, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Government Pub-
5 lishing Office Act of 2014”.

1 **SEC. 2. REDESIGNATION OF GOVERNMENT PRINTING OF-**
 2 **FICE TO GOVERNMENT PUBLISHING OFFICE.**

3 (a) IN GENERAL.—The Government Printing Office
 4 is hereby redesignated the Government Publishing Office.

5 (b) REFERENCES.—Any reference to the Government
 6 Printing Office in any law, rule, regulation, certificate, di-
 7 rective, instruction, or other official paper in force on the
 8 date of enactment of this Act shall be considered to refer
 9 and apply to the Government Publishing Office.

10 **SEC. 3. REDESIGNATION OF PUBLIC PRINTER TO DIREC-**
 11 **TOR OF THE GOVERNMENT PUBLISHING OF-**
 12 **FICE.**

13 (a) TITLE 44, UNITED STATES CODE.—Title 44,
 14 United States Code, is amended—

15 (1) by striking “Public Printer” each place that
 16 term appears and inserting “Director of the Govern-
 17 ment Publishing Office”; and

18 (2) in the heading for each of sections 301,
 19 302, 303, 304, 305, 306, 307, 502, 710, 1102,
 20 1111, 1115, 1340, 1701, 1712, and 1914, by strik-
 21 ing “**PUBLIC PRINTER**” and inserting “**DIRECTOR**
 22 **OF THE GOVERNMENT PUBLISHING OFFICE**”.

23 (b) OTHER REFERENCES.—Any reference in any law
 24 other than in title 44, United States Code, or in any rule,
 25 regulation, certificate, directive, instruction, or other offi-
 26 cial paper in force on the date of enactment of this Act

1 to the Public Printer shall be considered to refer and apply
2 to the Director of the Government Publishing Office.

3 **SEC. 4. REDESIGNATION OF DEPUTY PUBLIC PRINTER TO**
4 **DEPUTY DIRECTOR OF THE GOVERNMENT**
5 **PUBLISHING OFFICE.**

6 (a) TITLE 44, UNITED STATES CODE.—Title 44,
7 United States Code, is amended—

8 (1) by striking “Deputy Public Printer” each
9 place that term appears and inserting “Deputy Di-
10 rector of the Government Publishing Office”; and

11 (2) in the heading for each of sections 302 and
12 303, by striking “**DEPUTY PUBLIC PRINTER**” and
13 inserting “**DEPUTY DIRECTOR OF THE GOVERN-**
14 **MENT PUBLISHING OFFICE**”.

15 (b) OTHER REFERENCES.—Any reference in any law
16 other than in title 44, United States Code, or in any rule,
17 regulation, certificate, directive, instruction, or other offi-
18 cial paper in force on the date of enactment of this Act
19 to the Deputy Public Printer shall be considered to refer
20 and apply to the Deputy Director of the Government Pub-
21 lishing Office.

22 **SEC. 5. DIRECTOR REQUIREMENTS.**

23 Section 301 of title 44, United States Code, is
24 amended—

1 (1) in the first sentence, by striking “, who
2 must be a practical printer and versed in the art of
3 bookbinding,”; and

4 (2) in the second sentence, by striking “His”
5 and inserting “The”.

6 **SEC. 6. DEPUTY DIRECTOR REQUIREMENTS.**

7 Section 302 of title 44, United States Code, is
8 amended—

9 (1) in the first sentence, by striking “, who
10 must be a practical printer and versed in the art of
11 bookbinding,”; and

12 (2) in the second sentence—

13 (A) by striking “He” and inserting “The
14 Deputy Director of the Government Publishing
15 Office”;

16 (B) by striking “perform the duties for-
17 merly required of the chief clerk,”;

18 (C) by striking “, and perform” and in-
19 serting “and perform”; and

20 (D) by striking “of him”.

21 **SEC. 7. OTHER CONFORMING AMENDMENTS.**

22 Chapter 3 of title 44, United States Code is amend-
23 ed—

24 (1) in the first sentence of section 304, by
25 striking “or his” and inserting “or the Director’s”;

1 (2) in section 305(a)—

2 (A) by striking “he considers” and insert-
3 ing “the Director considers”; and

4 (B) by striking “He may not” and insert-
5 ing “The Director of the Government Pub-
6 lishing Office may not”;

7 (3) in section 306, by striking “his direction”
8 and inserting “the direction of the Director”;

9 (4) in section 308—

10 (A) in subsection (b)(1)—

11 (i) by striking “his accounts” and in-
12 serting “the accounts of the disbursing of-
13 ficer”; and

14 (ii) by striking “his name” and insert-
15 ing “the name of the disbursing officer”;

16 (B) in subsection (b)(2)—

17 (i) by striking “his estate” and insert-
18 ing “the estate of the disbursing officer”;

19 (ii) by striking “to him” and inserting
20 “to the deputy disbursing officer”; and

21 (iii) by striking “his service” and in-
22 serting “the service of the deputy dis-
23 bursing officer”; and

24 (C) in subsection (c)(1)—

1 (i) by striking “by him” and inserting
 2 “by such officer or employee”;

3 (ii) by striking “his discretion” and
 4 inserting “the discretion of the Comptroller
 5 General”; and

6 (iii) by striking “whenever he” each
 7 place that terms appears and inserting
 8 “whenever the Comptroller General”;

9 (5) in section 309—

10 (A) in the second sentence of subsection
 11 (a), by striking “by him” and inserting “by the
 12 Director”; and

13 (B) in subsection (f), by striking “his or
 14 her discretion” and inserting “the discretion of
 15 the Comptroller General”;

16 (6) in section 310, by striking “his written re-
 17 quest” and inserting “the written request of the Di-
 18 rector”;

19 (7) in section 311(b), by striking “he justifies”
 20 and inserting “the Director justifies”;

21 (8) in section 312, by striking “his service” and
 22 inserting “the service of such officer”; and

23 (9) in section 317, by striking “his delegate”
 24 and inserting “a delegate of the Director”.
