To amend certain definitions contained in the Provo River Project Transfer Act for purposes of clarifying certain property descriptions, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. CLARIFYING CERTAIN PROPERTY DESCRIP-**
 2 **TIONS IN PROVO RIVER PROJECT TRANSFER**
 3 **ACT.**

4 (a) PLEASANT GROVE PROPERTY.—Section 2(4)(A)
 5 of the Provo River Project Transfer Act (Public Law 108–
 6 382; 118 Stat. 2212) is amended by striking “of enact-
 7 ment of this Act” and inserting “on which the parcel is
 8 conveyed under section 3(a)(2)”.

9 (b) PROVO RESERVOIR CANAL.—Section 2(5) of the
 10 Provo River Project Transfer Act (Public Law 108–382;
 11 118 Stat. 2212) is amended—

12 (1) by striking “canal, and any associated land,
 13 rights-of-way, and facilities” and inserting “water
 14 conveyance facility historically known as the Provo
 15 Reservoir Canal and all associated bridges, fixtures,
 16 structures, facilities, lands, interests in land, and
 17 rights-of-way held,”;

18 (2) by inserting “and forebay” after “Diversion
 19 Dam”;

20 (3) by inserting “near the Jordan Narrows to
 21 the point where water is discharged to the Welby-
 22 Jacob Canal and the Utah Lake Distributing Canal”
 23 after “Penstock”; and

24 (4) by striking “of enactment of this Act” and
 25 inserting “on which the Provo Reservoir Canal is
 26 conveyed under section 3(a)(1)”.
