Mr. WALSH introduced the following bill; which was read twice and referred to the Committee on Homeland Security and Governmental Affairs

## A BILL

To prohibit congressional recesses until Congress adopts a concurrent resolution on the budget that results in a balanced federal budget by fiscal year 2024 and to control congressional travel budgets.

1       *Be it enacted by the Senate and House of Representa-*

2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Do Your Job Act”.

5       **SEC. 2. FINDINGS.**

6       Congress finds the following:

7           (1)       The       Federal       debt       exceeds

8           \$17,000,000,000,000 and continues to grow.

1                   (2) It is the responsibility of Members of Con-  
2                   gress to enact and implement policies that encourage  
3                   economic growth and job creation, including a bal-  
4                   anced budget.

5                   (3) In 2013, the House of Representatives was  
6                   in session only 160 days and the Senate was in ses-  
7                   sion only 156 days.

8                   (4) This means that, according to Federal Re-  
9                   serve Economic Data, the average American works  
10                  10 more weeks per year than Congress is in session.

11                  (5) Congressional recess in a time of excessive  
12                  national debt is a lost opportunity to reach agree-  
13                  ment about a balanced budget.

14 **SEC. 3. NO CONGRESSIONAL RECESSES.**

15                  (a) IN GENERAL.—During the period beginning on  
16                  the date of enactment of this Act and ending on the date  
17                  specified in subsection (b), neither the Senate nor the  
18                  House of Representatives may recess or stand adjourned  
19                  for a period of longer than 24 hours.

20                  (b) BALANCED BUDGET AGREED TO.—The date de-  
21                  scribed in this subsection is the date of enactment of a  
22                  concurrent resolution on the budget that establishes a level  
23                  of deficit of \$0 or a surplus by not later than fiscal year  
24                  2024.

1       (c) RULES OF HOUSE OF REPRESENTATIVES AND  
2 SENATE.—This section is enacted by Congress—

3               (1) as an exercise of the rulemaking power of  
4 the Senate and House of Representatives, respec-  
5 tively, and as such it is deemed a part of the rules  
6 of each House, respectively, and it supersedes other  
7 rules only to the extent that it is inconsistent with  
8 such rules; and

9               (2) with full recognition of the constitutional  
10 right of either House to change the rules (so far as  
11 relating to the procedure of that House) at any time,  
12 in the same manner, and to the same extent as in  
13 the case of any other rule of that House.

14 **SEC. 4. CONGRESSIONAL TRAVEL BUDGETS.**

15       (a) DEFINITION.—In this section, the term “em-  
16 ployee”, relating to a Member of Congress, means any in-  
17 dividual employed by the Member of Congress in—

18               (1) the office of the Member of Congress;  
19               (2) the office of a standing, select, or joint com-  
20 mittee of Congress (or a subcommittee thereof); or  
21               (3) a leadership office of the Senate or the  
22 House of Representatives.

23       (b) SUBMISSION OF BUDGET.—

24               (1) IN GENERAL.—Not later than the date by  
25 which the President is required to submit the budget

1       of the President for a fiscal year under section 1105  
2       of title 31, United States Code, each Member of  
3       Congress shall submit a budget for the fiscal year  
4       for official travel by the Member of Congress and  
5       employees of the Member of Congress in accordance  
6       with paragraph (2).

7                     (2) SUBMISSION.—The budget required under  
8       paragraph (1) shall—

9                         (A) in the case of a Senator, be submitted  
10                        to the Secretary of the Senate; and  
11                         (B) in the case of a Member of the House  
12                        of Representatives, shall be submitted to the  
13                        Chief Administrative Officer of the House of  
14                        Representatives.

15                     (c) RESCISSION OF UNSPENT TRAVEL FUNDS.—Ef-  
16       fective on October 1 of each fiscal year, any amounts made  
17       available for official travel by a Member of Congress or  
18       an employee of the Member of Congress during the pre-  
19       vious fiscal year that are not obligated shall be rescinded  
20       and used for deficit reduction.
