## A BILL

To amend title 17, United States Code, to extend expiring provisions of the Satellite Television Extension and Localism Act of 2010.

- 1       *Be it enacted by the Senate and House of Representa-*
- 2       *tives of the United States of America in Congress assembled,*
- 3       **SECTION 1. SHORT TITLE.**
- 4       *This Act may be cited as the “Satellite Television Ae-*
- 5       *cess Reauthorization Act of 2014”.*

1   **SEC. 2. REAUTHORIZATION.**

2       Chapter 1 of title 17, United States Code, is amend-

3   ed—

4           (1) in section 111(d)(3)—

5              (A) in the matter preceding subparagraph  
6              (A), by striking “clause” and inserting “para-  
7              graph”; and

8              (B) in subparagraph (B), by striking  
9              “clause” and inserting “paragraph”; and

10          (2) in section 119—

11             (A) in subsection (a)(6)(E), in the undesig-  
12             nated matter following clause (iii), by striking  
13             “clause (i)” and inserting “subparagraph  
14             (B)(i)”,

15             (B) in subsection (c)(1)(E), by striking  
16             “2014” and inserting “2019”,

17             (C) in subsection (e), by striking “2014”  
18             and inserting “2019”, and

19             (D) in subsection (g)(7)(C), by inserting  
20             “the” before “Communications”.

21   **SEC. 3. TERMINATION OF LICENSE.**

22       (a) In GENERAL.—Section 119 of title 17, United  
23       States Code, as amended in section 2, is amended by add-  
24       ing at the end the following:

25           “(h) TERMINATION OF LICENSE.—This section shall  
26           cease to be effective on December 31, 2019.”

1       (b) CONFORMING AMENDMENT.—Section 107(a) of  
2 the Satellite Television Extension and Localism Act of  
3 2010 (17 U.S.C. 119 note) is repealed.

4 **SECTION 1. SHORT TITLE.**

5       *This Act may be cited as the “Satellite Television Ac-*  
6 *cess Reauthorization Act of 2014”.*

7 **SEC. 2. REAUTHORIZATION.**

8       *Chapter 1 of title 17, United States Code, is amend-*  
9 *ed—*

10           (1) *in section 111(d)(3)—*

11              (A) *in the matter preceding subparagraph*  
12              (A), *by striking “clause” and inserting “para-*  
13              *graph”; and*

14              (B) *in subparagraph (B), by striking*  
15              *“clause” and inserting “paragraph”; and*

16           (2) *in section 119—*

17              (A) *in subsection (a)(6)(E), in the undesig-*  
18              *nated matter following clause (iii), by striking*  
19              *“clause (i)” and inserting “subparagraph*  
20              *(B)(i)”;*

21              (B) *in subsection (c)(1)(E), by striking*  
22              *“2014” and inserting “2019”;*

23              (C) *in subsection (e), by striking “2014”*  
24              *and inserting “2019”; and*

1                             (D) in subsection (g)(7)(C), by inserting  
2                             “the” before “Communications”.

3     **SEC. 3. TERMINATION OF LICENSE.**

4         (a) *IN GENERAL.*—Section 119 of title 17, United  
5     States Code, as amended in section 2, is amended by adding  
6     at the end the following:

7                             “(h) *TERMINATION OF LICENSE.*—This section shall  
8     cease to be effective on December 31, 2019.”.

9         (b) *CONFORMING AMENDMENT.*—Section 107(a) of the  
10    *Satellite Television Extension and Localism Act of 2010* (17  
11    U.S.C. 119 note) is repealed.

12     **SEC. 4. LOCAL SERVICE AREA OF A PRIMARY TRANSMITTER.**

13         Section 111(f)(4) of title 17, United States Code, is  
14     amended, in the second sentence—

15                             (1) by inserting “as defined by the rules and reg-  
16     ulations of the Federal Communications Commis-  
17     sion,” after “television station,”;

18                             (2) by striking “comprises the area within 35  
19     miles of the transmitter site, except that” and insert-  
20     ing “comprises the designated market area, as defined  
21     in section 122(j)(2)(C), that encompasses the commu-  
22     nity of license of such station and any community  
23     that is located outside such designated market area  
24     that is either wholly or partially within 35 miles of  
25     the transmitter site or;”; and

1                   (3) by striking "the number of miles shall be 20  
2                   miles" and inserting "wholly or partially within 20  
3                   miles of such transmitter site".
