Mr. RISCH (for himself and Mr. CRAPO) introduced the following bill; which was read twice and referred to the Committee on Energy and Natural Resources

A BILL

To require the Secretary of the Interior to convey certain Federal land to Idaho County in the State of Idaho, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Idaho County Shooting
5 Range Land Conveyance Act”.

6 **SEC. 2. DEFINITIONS.**

7 In this Act:

8 (1) COUNTY.—The term “County” means
9 Idaho County in the State of Idaho.

1 (2) MAP.—The term “map” means the map en-
 2 titled “Idaho County Land Conveyance” and dated
 3 April 11, 2014.

4 (3) SECRETARY.—The term “Secretary” means
 5 the Secretary of the Interior.

6 **SEC. 3. CONVEYANCE OF LAND TO IDAHO COUNTY.**

7 (a) IN GENERAL.—As soon as practicable after noti-
 8 fication by the County and subject to valid existing rights,
 9 the Secretary shall convey to the County, without consid-
 10 eration, all right, title, and interest of the United States
 11 in and to the Federal land described in subsection (b).

12 (b) DESCRIPTION OF LAND.—The Federal land re-
 13 ferred to in subsection (a) consists of approximately 31
 14 acres of land managed by the Bureau of Land Manage-
 15 ment and generally depicted on the map as “Convey-
 16 ance__Area”.

17 (c) MAP AND LEGAL DESCRIPTION.—

18 (1) IN GENERAL.—As soon as practicable after
 19 the date of enactment of this Act, the Secretary
 20 shall finalize the legal description of the parcel of
 21 Federal land to be conveyed under this section.

22 (2) MINOR ERRORS.—The Secretary may cor-
 23 rect any minor error in—

24 (A) the map; or

25 (B) the legal description.

1 (3) AVAILABILITY.—The map and legal descrip-
2 tion shall be on file and available for public inspec-
3 tion in the appropriate offices of the Bureau of
4 Land Management.

5 (d) USE OF CONVEYED LAND.—The land conveyed
6 under this section shall be used only as a shooting range.

7 (e) ADMINISTRATIVE COSTS.—The Secretary shall
8 require the County to pay all survey costs and other ad-
9 ministrative costs necessary for the preparation and com-
10 pletion of any patents for, and transfers of title to, the
11 Federal land described in subsection (b).

12 (f) CONDITIONS.—As a condition of the conveyance
13 under subsection (a), the County shall agree—

14 (1) to pay any administrative costs associated
15 with the conveyance, including the costs of any envi-
16 ronmental, wildlife, cultural, or historic resources
17 studies;

18 (2) to release and indemnify the United States
19 from any claims or liabilities that may arise from
20 uses carried out on the Federal land described in
21 subsection (b) on or before the date of enactment of
22 this Act by the United States or any person; and

23 (3) to accept such reasonable terms and condi-
24 tions as the Secretary determines necessary.
