A BILL

To direct the Secretary of the Interior to study the suitability and feasibility of designating sites in the Lower Mississippi River Area in the State of Louisiana as a unit of the National Park System, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Lower Mississippi
5 River Area Study Act”.

6 **SEC. 2. DEFINITIONS.**

7 In this Act:

8 (1) SECRETARY.—The term “Secretary” means
9 the Secretary of the Interior.

10 (2) STUDY AREA.—The term “study area” in-
11 cludes Fort St. Philip, Fort Jackson, the Head of
12 Passes, and any related and supporting historical,
13 cultural, and recreational resources located in
14 Plaquemines Parish, Louisiana.

15 **SEC. 3. STUDY.**

16 (a) IN GENERAL.—Not later than 3 years after the
17 date on which funds are made available to carry out this
18 Act, the Secretary, in consultation with the State of Lou-
19 isiana and other interested organizations, shall complete
20 a special resource study that evaluates—

21 (1) the national significance of the study area;
22 and

23 (2) the suitability and feasibility of designating
24 the study area as a unit of the National Park Sys-
25 tem.

1 (b) CRITERIA.—In conducting the study under sub-
2 section (a), the Secretary shall use the criteria for the
3 study of areas for potential inclusion in the National Park
4 System in section 8(c) of National Park System General
5 Authorities Act (16 U.S.C. 1a–5(c)).

6 (c) CONTENT.—The study described in subsection (a)
7 shall—

- 8 (1) include cost estimates for the potential ac-
9 quisition, development, operation, and maintenance
10 of the study area; and
11 (2) identify alternatives for the management,
12 administration, and protection of the study area.

13 **SEC. 4. AGREEMENT; DONATIONS.**

14 The study described in section 3 shall not be con-
15 ducted until the date on which—

- 16 (1) the Secretary enters into an agreement with
17 a State, unit of local government, or other entity to
18 conduct the study using non-Federal funds; or
19 (2) the Secretary receives a donation of an
20 amount of non-Federal funds sufficient to pay the
21 cost of conducting the study.
