A BILL

To create jobs and strengthen our economy by rebuilding
our Nation's infrastructure.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the “Rebuild America Act”.

5 SEC. 2. SENSE OF THE SENATE.

6 It is the sense of the Senate that Congress should—
7 (1) create jobs and support businesses while im-
8 proving our Nation’s global competitiveness by mod-

1 ernizing and strengthening our national infrastruc-
2 ture;

3 (2) invest resources in transportation corridors
4 of national and regional significance that promote
5 commerce and reduce congestion;

6 (3) update and enhance our national network of
7 rail, dams, and ports of the United States;

8 (4) develop innovative financing mechanisms for
9 infrastructure, such as an infrastructure bank, to le-
10 verage Federal funds with private sector partners;

11 (5) invest in critical infrastructure, such as a
12 smarter national energy grid, to reduce energy waste
13 and bolster investment in clean energy jobs and in-
14 dustries;

15 (6) invest in clean energy technologies that help
16 free the United States from its dependence on oil,
17 especially foreign oil;

18 (7) eliminate wasteful tax subsidies that pro-
19 mote pollution and fail to reduce our reliance on for-
20 eign oil;

21 (8) spur innovation by facilitating the develop-
22 ment of new cutting-edge broadband internet tech-
23 nology and improving internet access for all Ameri-
24 cans;

- 1 (9) modernize, renovate, and repair elementary
2 and secondary school buildings in public school dis-
3 tricts and community colleges across the United
4 States in order to support improved educational out-
5 comes in those schools;
- 6 (10) invest in the Nation's crumbling water in-
7 frastructure to protect public health and reduce pol-
8 lution;
- 9 (11) upgrade and repair the Nation's system of
10 flood protection infrastructure, such as levees, to
11 protect public safety; and
- 12 (12) invest in the infrastructure of the United
13 States to address vulnerabilities to natural disasters
14 and the impacts of extreme weather.
