Mrs. FEINSTEIN introduced the following bill; which was read twice and referred to the Committee on the Judiciary

A BILL

For the relief of Jorge Rojas Gutierrez, Oliva Gonzalez Gonzalez, and Jorge Rojas Gonzalez.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PERMANENT RESIDENT STATUS FOR JORGE**
4 **ROJAS GUTIERREZ, OLIVA GONZALEZ GON-**
5 **ZALEZ, AND JORGE ROJAS GONZALEZ.**

6 (a) IN GENERAL.—Notwithstanding subsections (a)
7 and (b) of section 201 of the Immigration and Nationality
8 Act (8 U.S.C. 1151), Jorge Rojas Gutierrez, Oliva Gon-
9 zalez Gonzalez, and Jorge Rojas Gonzalez shall each be
10 eligible for the issuance of an immigrant visa or for adjust-

1 ment of status to that of an alien lawfully admitted for
2 permanent residence upon filing an application for
3 issuance of an immigrant visa under section 204 of such
4 Act (8 U.S.C. 1154) or for adjustment of status to lawful
5 permanent resident.

6 (b) ADJUSTMENT OF STATUS.—If Jorge Rojas
7 Gutierrez, Oliva Gonzalez Gonzalez, or Jorge Rojas Gon-
8 zalez enters the United States before the filing deadline
9 specified in subsection (c), Jorge Rojas Gutierrez, Oliva
10 Gonzalez Gonzalez, or Jorge Rojas Gonzalez, as appro-
11 priate, shall be considered to have entered and remained
12 lawfully in the United States and shall be eligible for ad-
13 justment of status under section 245 of the Immigration
14 and Nationality Act (8 U.S.C. 1255) as of the date of the
15 enactment of this Act.

16 (c) DEADLINE FOR APPLICATION AND PAYMENT OF
17 FEES.—Subsections (a) and (b) shall apply only if the ap-
18 plication for the issuance of an immigrant visa or the ap-
19 plication for adjustment of status is filed with appropriate
20 fees not later than 2 years after the date of the enactment
21 of this Act.

22 (d) REDUCTION OF IMMIGRANT VISA NUMBERS.—
23 Upon granting an immigrant visa or permanent residence
24 to Jorge Rojas Gutierrez, Oliva Gonzalez Gonzalez, and
25 Jorge Rojas Gonzalez, the Secretary of State shall instruct

1 the proper officer to reduce by 3, during the current or
2 subsequent fiscal year, the total number of immigrant
3 visas that are made available to natives of the country of
4 birth of Jorge Rojas Gutierrez, Oliva Gonzalez Gonzalez,
5 and Jorge Rojas Gonzalez under section 203(a) of the Im-
6 migration and Nationality Act (8 U.S.C. 1153(a)) or, if
7 applicable, the total number of immigrant visas that are
8 made available to natives of the country of birth of Jorge
9 Rojas Gutierrez, Oliva Gonzalez Gonzalez, and Jorge
10 Rojas Gonzalez under section 202(e) of such Act (8 U.S.C.
11 1152(e)).

12 (e) PAYGO.—The budgetary effects of this Act, for
13 the purpose of complying with the Statutory Pay-As-You-
14 Go Act of 2010, shall be determined by reference to the
15 latest statement titled “Budgetary Effects of PAYGO
16 Legislation” for this Act, submitted for printing in the
17 Congressional Record by the Chairman of the Senate
18 Budget Committee, provided that such statement has been
19 submitted prior to the vote on passage.
