## A BILL

To rescind certain Federal funds identified by States as unwanted and use the funds to reduce the Federal debt.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Returned Exclusively  
5 For Unpaid National Debt Act” or the “REFUND Act”.

1 **SEC. 2. USE OF UNWANTED FEDERAL FUNDS TO REDUCE**  
2 **FEDERAL DEBT.**

3 (a) **RESCISSION OF UNWANTED FEDERAL FUNDS.—**

4 There is rescinded, from any Federal funds required to  
5 be allocated by formula among all States that agree to  
6 use such funds for a specified purpose, an amount equal  
7 to the amount of such funds that would have otherwise  
8 been allocated to a State that identifies such funds under  
9 subsection (b) as unwanted.

10 (b) **IDENTIFICATION OF FUNDS.—**Subsection (a)  
11 shall only apply if, not later than the last date on which  
12 an application or State plan must be submitted in order  
13 for a State to be allocated, in an annual or biennial budget  
14 cycle, funds described in such subsection—

15 (1) the State legislature with jurisdiction over  
16 such budget cycle adopts a concurrent resolution  
17 identifying the funds as unwanted; and

18 (2) the State submits notice of the resolution  
19 described in paragraph (1) to the agency head re-  
20 sponsible for allocation of the funds, in such form  
21 and manner and containing such information as the  
22 agency head determines appropriate to make the de-  
23 termination in subsection (c).

24 (c) **DETERMINATION OF AMOUNT TO BE RE-**  
25 **SCINDED.—**An agency head that receives notice described  
26 in subsection (b)(2) shall determine and report to the Of-

1 fice of Management and Budget the amount to be re-  
2 scinded under subsection (a).

3 (d) USE FOR REDUCTION OF FEDERAL DEBT.—

4 Amounts rescinded under subsection (a) shall be deposited  
5 by the Secretary of the Treasury in the special fund ac-  
6 count “Gifts to Reduce Debt Held by the Public, Bureau  
7 of the Public Debt, Treasury” and used to reduce the Fed-  
8 eral debt as provided in section 3113(d) of title 31, United  
9 States Code.

10 (e) ANNUAL REPORT.—The Secretary of the Treas-  
11 ury shall submit to the Congress each year a report identi-  
12 fying the amount deposited in the Treasury under sub-  
13 section (d) with respect to each State in such year.

14 (f) DEFINITIONS.—In this section:

15 (1) The term “agency head” means the head of  
16 a department or agency of the Federal Government.

17 (2) The term “State” means—

18 (A) each of the several States;

19 (B) the District of Columbia; or

20 (C) any commonwealth, territory, or pos-  
21 session of the United States.
