Mr. LEVIN introduced the following bill; which was read twice and referred
to the Committee on the Judiciary

A BILL

For the relief of Ibrahim Parlak.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. ADJUSTMENT OF STATUS.**

4 (a) IN GENERAL.—Notwithstanding any other provi-
5 sion of law, for the purposes of the Immigration and Na-
6 tionality Act (8 U.S.C. 1101 et seq.), Ibrahim Parlak shall
7 be deemed to have been lawfully admitted to, and re-
8 mained in, the United States, and shall be eligible for ad-
9 justment of status to that of an alien lawfully admitted
10 for permanent residence under section 245 of the Immi-
11 gration and Nationality Act (8 U.S.C. 1255) upon filing
12 an application for such adjustment of status.

1 (b) APPLICATION AND PAYMENT OF FEES.—Sub-
2 section (a) shall apply only if the application for adjust-
3 ment of status is filed with appropriate fees not later than
4 2 years after the date of the enactment of this Act.

5 (c) REDUCTION OF IMMIGRANT VISA NUMBERS.—
6 Upon the granting of permanent resident status to
7 Ibrahim Parlak, the Secretary of State shall instruct the
8 proper officer to reduce by 1, during the current or next
9 following fiscal year, the total number of immigrant visas
10 that are made available to natives of the country of the
11 birth of Ibrahim Parlak under section 202(a)(2) of the
12 Immigration and Nationality Act (8 U.S.C. 1152(a)(2)).
