To authorize the use of United States Armed Forces against the Islamic State in Iraq and the Levant.

Mr. Kaine introduced the following joint resolution; which was read twice and referred to the Committee on Foreign Relations

## JOINT RESOLUTION

To authorize the use of United States Armed Forces against the Islamic State in Iraq and the Levant.

Whereas that the Islamic State in Iraq and the Levant (ISIL), also known as ISIS or the Islamic State, is a terrorist organization committing daily acts of barbarity currently encompassing large portions of Syria and Iraq, and is a serious threat to the United States and the international community;

Whereas ISIL's violence is destructive of religious freedom, the equality of women, protections against genocide, principles of national sovereignty, freedom of expression, and other core human rights protected by international law;

Whereas ISIL's grisly execution of United States hostages, recruitment of United States citizens and others to serve as foreign fighters that threaten to return to the United

States and other nations, and pledges to carry out additional acts of violence directly against the United States make it a threat of growing significance to the United States; and

Whereas United Nations Security Council Resolutions 2169 (2014) and 2170 (2014) note that ISIL's advancement is a major threat to Iraq's future, condemn attacks by ISIL, reiterate international community support for Iraq's security and territorial integrity, and emphasize the need for the international community to work together to help stabilize Iraq and combat ISIL: Now, therefore, be it

1       *Resolved by the Senate and House of Representatives*  
2    *of the United States of America in Congress assembled,*

3   **SECTION 1. SHORT TITLE.**

4       This joint resolution may be cited as the “Authorization  
5    for Use of Military Force against the Islamic State  
6    in Iraq and the Levant”.

7   **SEC. 2. AUTHORIZATION FOR USE OF UNITED STATES**  
8                   **ARMED FORCES AGAINST THE ISLAMIC**  
9                   **STATE IN IRAQ AND THE LEVANT.**

10      (a) IN GENERAL.—In order to protect the United  
11    States and other countries from terrorist attacks by the  
12    Islamic State in Iraq and the Levant (ISIL), and in order  
13    to protect individuals from acts of violence in clear con-  
14    travention of international law and basic human rights,  
15    the President is authorized, as part of a multinational coa-  
16    lition, subject to the limitations in subsection (b)—

1                             (1) to use all necessary and appropriate force to  
2                             participate in a campaign of airstrikes in Iraq, and  
3                             if the President deems necessary, in Syria, to de-  
4                             grade and defeat ISIL; and

5                             (2) to provide military equipment and training  
6                             to forces fighting ISIL in Iraq or Syria, including  
7                             the Iraqi security forces, Kurdish fighters, and other  
8                             legitimate, appropriately vetted, non-terrorist opposi-  
9                             tion groups in Syria.

10                         (b) NO AUTHORIZATION FOR USE OF GROUND  
11                         FORCES OR FORCE AGAINST ASSOCIATED FORCES.—The  
12                         authorization in this section does not include—

13                         (1) authorization for the use of United States  
14                         ground combat forces, except for the purposes set  
15                         forth in subsection (a)(2) or as necessary for the  
16                         protection or rescue of members of the United  
17                         States Armed Forces or United States citizens from  
18                         imminent danger posed by ISIL, or for limited oper-  
19                         ations against high value targets; or

20                         (2) authorization for the use of force against  
21                         forces associated with ISIL, unless such forces are  
22                         identified in a report submitted under section 4 as  
23                         individuals or organizations that are immediately  
24                         and directly fighting alongside ISIL in Iraq and  
25                         Syria.

1       (c) EXPIRATION.—The authorization in this section  
2 shall expire on the date that is one year after the date  
3 of the enactment of this joint resolution.

4       (d) WAR POWERS RESOLUTION REQUIREMENTS.—

5           (1) SPECIFIC STATUTORY AUTHORIZATION.—  
6       Consistent with section 8(a)(1) of the War Powers  
7 Resolution, the Congress declares that this section is  
8 intended to constitute specific statutory authoriza-  
9 tion within the meaning of section 5(b) of the War  
10 Powers Resolution.

11          (2) APPLICABILITY OF OTHER REQUIRE-  
12 MENTS.—Nothing in this resolution supercedes any  
13 requirement of the War Powers Resolution.

14 **SEC. 3. REPEAL OF PRIOR AUTHORIZATION FOR USE OF**  
15           **UNITED STATES ARMED FORCES AGAINST**  
16           **IRAQ.**

17       The Authorization for the Use of Military Force  
18 Against Iraq Resolution of 2002 (Public Law 107–243;  
19 50 U.S.C. 1541 note) is hereby repealed.

20 **SEC. 4. DESIGNATION OF ORGANIZATIONS AND INDIVID-**  
21           **UALS IMMEDIATELY AND DIRECTLY FIGHT-**  
22           **ING ALONGSIDE ISIL.**

23       Not later than 90 days after the date of the enact-  
24 ment of this resolution, and every 90 days thereafter, the  
25 President shall submit to Congress a list of those organi-

1 zations or individuals immediately and directly fighting  
2 alongside ISIL for purposes of actions taken pursuant to  
3 this joint resolution. The list shall be maintained in un-  
4 classified form but may contain a classified annex.

5 **SEC. 5. REPORTS.**

6 The President shall report to Congress every 90 days  
7 after enactment of this resolution regarding the progress  
8 of the effort against ISIL.

9 **SEC. 6. RULES OF CONSTRUCTION.**

10 Nothing in this resolution shall be construed as—

11 (1) authorizing support for force in support of,  
12 or in cooperation with, the national government of  
13 Syria that was in power as of the date of the enact-  
14 ment of this resolution, or its security services; or

15 (2) limiting the constitutional or statutory pow-  
16 ers of the President or Congress, or any additional  
17 powers held by the United States pursuant to inter-  
18 national law or treaty.
