- 6 time of any reassembly pursuant to section 3 of this con-
- 7 current resolution.
- 8 Sec. 2. (a) The Speaker or his designee, after con-
- 9 sultation with the Minority Leader of the House, shall no-
- 10 tify the Members of the House to reassemble at such place
- 11 and time as he may designate if, in his opinion, the public
- 12 interest shall warrant it.
- 13 (b) After reassembling pursuant to subsection (a),
- 14 when the House adjourns on a motion offered pursuant
- 15 to this subsection by its Majority Leader or his designee,
- 16 the House shall again stand adjourned pursuant to the
- 17 first section of this concurrent resolution.
- 18 Sec. 3. (a) The Majority Leader of the Senate or his
- 19 designee, after concurrence with the Minority Leader of
- 20 the Senate, shall notify the Members of the Senate to reas-
- 21 semble at such place and time as he may designate if, in
- 22 his opinion, the public interest shall warrant it.
- 23 (b) After reassembling pursuant to subsection (a),
- 24 when the Senate adjourns on a motion offered pursuant
- 25 to this subsection by its Majority Leader or his designee,

- 1 the Senate shall again stand adjourned pursuant to the
- 2 first section of this concurrent resolution.
- 3 Sec. 4. (a) When the Senate recesses or adjourns on
- 4 any day of the second session of the One Hundred Four-
- 5 teenth Congress from Sunday, January 3, 2016, through
- 6 Friday, January 8, 2016, on a motion offered pursuant
- 7 to this concurrent resolution by its Majority Leader or his
- 8 designee, it shall stand recessed or adjourned until noon
- 9 on Monday, January 11, 2016, or until such other time
- 10 on that day as may be specified by its Majority Leader
- 11 or his designee in the motion to recess or adjourn, or until
- 12 the time of any reassembly pursuant to subsection (b),
- 13 whichever occurs first.
- 14 (b) The Majority Leader of the Senate or his des-
- 15 ignee, after concurrence with the Minority Leader of the
- 16 Senate, shall notify the Members of the Senate to reassem-
- 17 ble at such place and time as he may designate if, in his
- 18 opinion, the public interest shall warrant it.
- (c) After reassembling pursuant to subsection (b),
- 20 when the Senate recesses or adjourns on a motion offered
- 21 pursuant to this subsection by its Majority Leader or his
