Mr. GUTHRIE introduced the following bill; which was referred to the Committee on Energy and Commerce

A BILL

To amend title XIX of the Social Security Act to require States to submit an annual report on sources of funds used to finance the non-Federal share of expenditures under such title, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Medicaid Requiring
5 Expenditures for Public Objectives to be Reflective of
6 Total Spending Act” or the “Medicaid REPORTS Act”.

1 **SEC. 2. REQUIRING STATES TO SUBMIT AN ANNUAL RE-**
2 **PORT OF SOURCES FUNDS USED TO FINANCE**
3 **THE NON-FEDERAL SHARE OF MEDICAID.**

4 (a) IN GENERAL.—Section 1903(w)(6) of the Social
5 Security Act (42 U.S.C. 1396b(w)(6)) is amended by add-
6 ing at the end the following new subparagraphs:

7 “(C) With respect to fiscal year 2016 and each
8 fiscal year thereafter, the Secretary shall require
9 each State to submit, using formats and standards
10 established and updated as necessary by the Sec-
11 retary, a report that identifies each source of funds,
12 each entity providing such funds, and the amount of
13 funds from each such source, used by the State to
14 finance the non-Federal share of expenditures under
15 this title. Such report shall provide such information
16 as the Secretary determines is sufficient to ensure
17 the State’s compliance with the requirements of this
18 title applicable to financing such non-Federal share
19 with respect to each of the following sources of
20 funds:

21 “(i) State appropriations or transfers to
22 the State agency administering the State plan
23 under this title, or to other State agencies or
24 government entities that are used to finance
25 such non-Federal share of payments under this
26 title.

1 “(ii) Bona fide provider-related donations
 2 (as defined in paragraph (2)(B)) and donation
 3 revenue (as defined in paragraph (2)(C)).

4 “(iii) Intergovernmental transfers from
 5 units of government within the State.

6 “(iv) Certified public expenditures from
 7 units of government within the State.

8 “(v) Any other sources as determined nec-
 9 essary by the Secretary.

10 “(D) The Secretary shall make the information
 11 reported under subparagraph (C) publicly available
 12 through publication on the Internet site of the Cen-
 13 ters for Medicare & Medicaid Services.”.

14 (b) CONFORMING AMENDMENT.—Section
 15 1903(w)(6)(A) of such Act (42 U.S.C. 1396b(w)(6)(A))
 16 is amended by inserting “, or are not reported as required
 17 under subparagraph (C)” after “this section”.
