A BILL

To amend the Intermodal Surface Transportation Efficiency Act of 1991 to designate the Sonoran Corridor connecting Interstate 19 to Interstate 10 south of the Tucson International Airport as a future part of the Interstate System, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Sonoran Corridor
5 Interstate Development Act of 2015”.

1 **SEC. 2. FINDING.**

2 Congress finds that the designation of the Sonoran
3 Corridor Interstate connecting Interstate 19 to Interstate
4 10 south of the Tucson International Airport as a future
5 part of the Interstate System would—

6 (1) enhance direct linkage between major trad-
7 ing routes connecting growing ports, agricultural re-
8 gions, infrastructure and manufacturing centers,
9 and existing high priority corridors of the National
10 Highway System; and

11 (2) significantly improve connectivity on the fu-
12 ture Interstate 11 and the CANAMEX Corridor, a
13 route directly linking the United States with Mexico
14 and Canada.

15 **SEC. 3. ROUTE DESIGNATION.**

16 (a) HIGH PRIORITY CORRIDOR ON NATIONAL HIGH-
17 WAY SYSTEM.—Section 1105(c) of the Intermodal Surface
18 Transportation Efficiency Act of 1991 (105 Stat. 2032;
19 119 Stat. 1210) is amended by adding at the end the fol-
20 lowing:

21 “(81) State Route 410, the Sonoran Corridor
22 connecting Interstate 19 to Interstate 10 south of
23 the Tucson International Airport.”.

24 (b) FUTURE PARTS OF INTERSTATE SYSTEM.—Sec-
25 tion 1105(e)(5)(A) of the Intermodal Surface Transpor-
26 tation Efficiency Act of 1991 (105 Stat. 2033; 119 Stat.

1 1213) is amended in the first sentence by striking “and
2 subsection (c)(57)” and inserting “subsection (c)(57), and
3 subsection (c)(81)”.
