A BILL

To establish an interagency working group to study the use of unmanned aircraft systems for wildland firefighting, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Protecting Firefighters
5 and Promoting Innovation Act”.

1 **SEC. 2. INTERAGENCY WORKING GROUP ON THE USE OF**
2 **UNMANNED AIRCRAFT SYSTEMS FOR**
3 **WILDLAND FIREFIGHTING.**

4 (a) ESTABLISHMENT.—Not later than 90 days after
5 the date of enactment of this Act, the President shall es-
6 tablish an interagency working group to study the use of
7 unmanned aircraft systems for wildland firefighting.

8 (b) MEMBERS.—The working group established
9 under subsection (a) shall include—

10 (1) the Administrator of the Federal Aviation
11 Administration and the Secretary of the Interior,
12 who shall serve as co-chairs of the working group;

13 (2) one representative, selected by the co-chairs,
14 with wildland firefighting experience from each of—

15 (A) a State firefighting agency;

16 (B) a local firefighting agency; and

17 (C) a volunteer firefighting agency; and

18 (3) at least one senior-level representative from
19 each of—

20 (A) the Department of Agriculture;

21 (B) the National Aeronautics and Space
22 Administration;

23 (C) the National Guard Bureau;

24 (D) the Federal Emergency Management
25 Agency; and

1 (E) the National Oceanic and Atmospheric
2 Administration.

3 (c) FUNCTIONS.—The working group established
4 under subsection (a) shall carry out functions including
5 the following:

6 (1) In consultation with national fire service or-
7 ganizations, adjutants general from States affected
8 by wildland fires, representatives from relevant in-
9 dustries, and other stakeholders developing stand-
10 ards and best practices for the use of unmanned air-
11 craft systems for wildland firefighting to—

12 (A) assist in fire suppression;

13 (B) provide real-time updates for fire-
14 fighters; and

15 (C) reduce the risk of firefighter fatalities
16 due to wildland firefighting and to aircraft acci-
17 dents related to wildland firefighting.

18 (2) Assessing existing Federal unmanned air-
19 craft systems to identify opportunities to use such
20 existing systems to lower the costs of the use of un-
21 manned aircraft systems for wildland firefighting.

22 (3) Assessing opportunities to improve inter-
23 agency coordination with respect to the use of un-
24 manned aircraft systems for wildland firefighting.

1 (4) With respect to the use of unmanned air-
2 craft systems for wildland firefighting, assessing—

3 (A) the efficacy of current technology; and

4 (B) the potential efficacy of emerging tech-
5 nology.

6 (5) In consultation with legal experts, assessing
7 the implications for the Fourth Amendment of the
8 Constitution of any standards, best practices, or rec-
9 ommendations under this section with respect to the
10 use of unmanned aircraft systems.

11 (d) REPORT.—Not later than 1 year after the date
12 of the establishment of the working group under sub-
13 section (a), the co-chairs of the working group shall sub-
14 mit to the committees of the House of Representatives and
15 the Senate with relevant jurisdiction and the National
16 Wildfire Coordinating Group a report containing the re-
17 sults of the work of the working group. Such report shall
18 include—

19 (1) the standards and best practices developed
20 under paragraph (1) of subsection (c);

21 (2) a summary of the assessments under para-
22 graphs (2), (3), (4), and (5) of such subsection; and

23 (3) any recommendations with respect to the
24 use of unmanned aircraft systems for wildland fire-
25 fighting.

1 (e) UNMANNED AIRCRAFT SYSTEM DEFINED.—In
2 this section, the term “unmanned aircraft system” has the
3 meaning given such term in section 331 of the FAA Mod-
4 ernization and Reform Act of 2012 (49 U.S.C. 40101
5 note).
