A BILL

To amend the Reclamation Wastewater and Groundwater Study and Facilities Act to authorize certain recycled water projects, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “California Water Recy-
5 cling and Drought Relief Act”.

6 **SEC. 2. PROJECT AUTHORIZATIONS.**

7 (a) IN GENERAL.—The Reclamation Wastewater and
8 Groundwater Study and Facilities Act (43 U.S.C. 390h
9 et seq.) (as amended by section 512(a) of the Consolidated

1 Natural Resources Act of 2008) is amended by adding at
2 the end the following:

3 **“SEC. 16____. BENICIA RECYCLED WATER PROJECT TO**
4 **VALERO REFINERY.**

5 “(a) AUTHORIZATION.—The Secretary, in coopera-
6 tion with the City of Benicia, California, is authorized to
7 participate in the design, planning, and construction of re-
8 cycled water system facilities.

9 “(b) COST SHARE.—The Federal share of the cost
10 of the project authorized by this section shall not exceed
11 25 percent of the total cost of the project.

12 “(c) LIMITATION.—The Secretary shall not provide
13 funds for the operation and maintenance of the project
14 authorized by this section.

15 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
16 is authorized to be appropriated to carry out this section
17 \$4,000,000.

18 **“SEC. 16____. BRENTWOOD RECYCLED WATER PROJECT.**

19 “(a) AUTHORIZATION.—The Secretary, in coopera-
20 tion with the City of Brentwood, California, is authorized
21 to participate in the design, planning, and construction of
22 recycled water system facilities.

23 “(b) COST SHARE.—The Federal share of the cost
24 of the project authorized by this section shall not exceed
25 25 percent of the total cost of the project.

1 “(c) LIMITATION.—The Secretary shall not provide
2 funds for the operation and maintenance of the project
3 authorized by this section.

4 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
5 is authorized to be appropriated to carry out this section
6 \$5,200,000.

7 **“SEC. 16____. CENTRAL DUBLIN RECYCLED WATER DIS-**
8 **TRIBUTION AND RETROFIT PROJECT.**

9 “(a) AUTHORIZATION.—The Secretary, in coopera-
10 tion with the Dublin San Ramon Services District, Cali-
11 fornia, is authorized to participate in the design, planning,
12 and construction of recycled water system facilities.

13 “(b) COST SHARE.—The Federal share of the cost
14 of the project authorized by this section shall not exceed
15 25 percent of the total cost of the project.

16 “(c) LIMITATION.—The Secretary shall not provide
17 funds for the operation and maintenance of the project
18 authorized by this section.

19 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
20 is authorized to be appropriated to carry out this section
21 \$1,150,000.

22 **“SEC. 16____. CENTRAL REDWOOD CITY RECYCLED WATER**
23 **PROJECT.**

24 “(a) AUTHORIZATION.—The Secretary, in coopera-
25 tion with the City of Redwood City, California, is author-

1 ized to participate in the design, planning, and construc-
 2 tion of recycled water system facilities.

3 “(b) COST SHARE.—The Federal share of the cost
 4 of the project authorized by this section shall not exceed
 5 25 percent of the total cost of the project.

6 “(c) LIMITATION.—The Secretary shall not provide
 7 funds for the operation and maintenance of the project
 8 authorized by this section.

9 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
 10 is authorized to be appropriated to carry out this section
 11 \$8,000,000.

12 **“SEC. 16 ____ . CONCORD RECYCLED WATER PROJECT.**

13 “(a) AUTHORIZATION.—The Secretary, in coopera-
 14 tion with the Central Contra Costa Sanitary District, Cali-
 15 fornia, is authorized to participate in the design, planning,
 16 and construction of recycled water system facilities.

17 “(b) COST SHARE.—The Federal share of the cost
 18 of the project authorized by this section shall not exceed
 19 25 percent of the total cost of the project.

20 “(c) LIMITATION.—The Secretary shall not provide
 21 funds for the operation and maintenance of the project
 22 authorized by this section.

23 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
 24 is authorized to be appropriated to carry out this section
 25 \$1,800,000.

1 **“SEC. 16____. CONTRA COSTA COUNTY REFINERY RECY-**
2 **CLED WATER PROJECT, PHASE 1.**

3 “(a) AUTHORIZATION.—The Secretary, in coopera-
4 tion with the Central Contra Costa Sanitary District, Cali-
5 fornia, is authorized to participate in the design, planning,
6 and construction of recycled water system facilities.

7 “(b) COST SHARE.—The Federal share of the cost
8 of the project authorized by this section shall not exceed
9 25 percent of the total cost of the project.

10 “(c) LIMITATION.—The Secretary shall not provide
11 funds for the operation and maintenance of the project
12 authorized by this section.

13 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
14 is authorized to be appropriated to carry out this section
15 \$6,250,000.

16 **“SEC. 16____. DELTA DIABLO RECYCLED WATER PROJECT.**

17 “(a) AUTHORIZATION.—The Secretary, in coopera-
18 tion with the Delta Diablo, California, is authorized to
19 participate in the design, planning, and construction of re-
20 cycled water system facilities.

21 “(b) COST SHARE.—The Federal share of the cost
22 of the project authorized by this section shall not exceed
23 25 percent of the total cost of the project.

24 “(c) LIMITATION.—The Secretary shall not provide
25 funds for the operation and maintenance of the project
26 authorized by this section.

1 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
 2 is authorized to be appropriated to carry out this section
 3 \$8,500,000.

4 **“SEC. 16____. DELTA DIABLO HIGH PURITY WATER TREAT-**
 5 **MENT FACILITY.**

6 “(a) AUTHORIZATION.—The Secretary, in coopera-
 7 tion with the Delta Diablo, California, is authorized to
 8 participate in the design, planning, and construction of re-
 9 cycled water system facilities.

10 “(b) COST SHARE.—The Federal share of the cost
 11 of the project authorized by this section shall not exceed
 12 25 percent of the total cost of the project.

13 “(c) LIMITATION.—The Secretary shall not provide
 14 funds for the operation and maintenance of the project
 15 authorized by this section.

16 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
 17 is authorized to be appropriated to carry out this section
 18 \$12,500,000.

19 **“SEC. 16____. DUBLIN RECYCLED WATER EXPANSION**

21 “(a) AUTHORIZATION.—The Secretary, in coopera-

 23 fornia, is authorized to participate in the design, planning,
 24 and construction of recycled water system facilities.

1 “(b) COST SHARE.—The Federal share of the cost
2 of the project authorized by this section shall not exceed
3 25 percent of the total cost of the project.

4 “(c) LIMITATION.—The Secretary shall not provide
5 funds for the operation and maintenance of the project
6 authorized by this section.

7 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
8 is authorized to be appropriated to carry out this section
9 \$5,275,000.

4 of the project authorized by this section shall not exceed
5 25 percent of the total cost of the project.

6 “(c) LIMITATION.—The Secretary shall not provide
7 funds for the operation and maintenance of the project
8 authorized by this section.

9 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
10 is authorized to be appropriated to carry out this section

18 “(b) COST SHARE.—The Federal share of the cost
19 of the project authorized by this section shall not exceed
20 25 percent of the total cost of the project.

21 “(c) LIMITATION.—The Secretary shall not provide
22 funds for the operation and maintenance of the project
23 authorized by this section.

1 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
2 is authorized to be appropriated to carry out this section
3 \$7,250,000.

4 **“SEC. 16____. IRONHOUSE SANITARY DISTRICT DIRECT PO-**

6 “(a) AUTHORIZATION.—The Secretary, in coopera-

8 authorized to participate in the design, planning, and con-
9 struction of recycled water distribution systems.

10 “(b) COST SHARE.—The Federal share of the cost
11 of the project authorized by this section shall not exceed
12 25 percent of the total cost of the project.

13 “(c) LIMITATION.—The Secretary shall not provide
14 funds for the operation and maintenance of the project
15 authorized by this section.

16 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
17 is authorized to be appropriated to carry out this section
18 \$10,000,000.

19 **“SEC. 16____. PURE WATER MONTEREY A GROUNDWATER**

23 Agency, Monterey, California, is authorized to participate
24 in the design, planning, and construction of recycled water
25 system facilities.

1 “(b) COST SHARE.—The Federal share of the cost
2 of the project authorized by this section shall not exceed
3 25 percent of the total cost of the project.

4 “(c) LIMITATION.—The Secretary shall not provide
5 funds for the operation and maintenance of the project
6 authorized by this section.

7 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
8 is authorized to be appropriated to carry out this section
9 \$7,500,000.

3 “(b) COST SHARE.—The Federal share of the cost
4 of the project authorized by this section shall not exceed
5 25 percent of the total cost of the project.

6 “(c) LIMITATION.—The Secretary shall not provide
7 funds for the operation and maintenance of the project
8 authorized by this section.

9 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
10 is authorized to be appropriated to carry out this section
11 \$20,400,000.

20 25 percent of the total cost of the project.

21 “(c) LIMITATION.—The Secretary shall not provide
22 funds for the operation and maintenance of the project
23 authorized by this section.

1 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
2 is authorized to be appropriated to carry out this section
3 \$6,000,000.

6 “(a) AUTHORIZATION.—The Secretary, in coopera-
7 tion with the City of Sunnyvale, California, is authorized
8 to participate in the design, planning, and construction of
9 recycled water system facilities.

10 “(b) COST SHARE.—The Federal share of the cost
11 of the project authorized by this section shall not exceed
12 25 percent of the total cost of the project.

13 “(c) LIMITATION.—The Secretary shall not provide
14 funds for the operation and maintenance of the project
15 authorized by this section.

16 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
17 is authorized to be appropriated to carry out this section
18 \$500,000.

19 **“SEC. 16____. WEST BAY SANITARY DISTRICT RECYCLED**
20 **WATER PROJECT.**

21 “(a) AUTHORIZATION.—The Secretary, in coopera-

23 authorized to participate in the design, planning, and con-
24 struction of recycled water system facilities.

1 “(b) COST SHARE.—The Federal share of the cost
2 of the project authorized by this section shall not exceed
3 25 percent of the total cost of the project.

4 “(c) LIMITATION.—The Secretary shall not provide
5 funds for the operation and maintenance of the project
6 authorized by this section.

7 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
8 is authorized to be appropriated to carry out this section
9 \$3,250,000.

10 **“SEC. 16____. WOLFE ROAD RECYCLED WATER PROJECT.**

11 “(a) AUTHORIZATION.—The Secretary, in coopera-
12 tion with the Santa Clara Valley Water District and the
13 City of Sunnyvale, California, is authorized to participate
14 in the design, planning, and construction of recycled water
15 system facilities.

16 “(b) COST SHARE.—The Federal share of the cost
17 of the project authorized by this section shall not exceed
18 25 percent of the total cost of the project.

19 “(c) LIMITATION.—The Secretary shall not provide
20 funds for the operation and maintenance of the project
21 authorized by this section.

22 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
23 is authorized to be appropriated to carry out this section
24 \$4,375,000.

1 **“SEC. 16____. YOUNTVILLE RECYCLED WATER PROJECT.**

2 “(a) AUTHORIZATION.—The Secretary, in coopera-
3 tion with the Town of Yountville, California, is authorized
4 to participate in the design, planning, and construction of
5 recycled water system facilities.

6 “(b) COST SHARE.—The Federal share of the cost
7 of the project authorized by this section shall not exceed
8 25 percent of the total cost of the project.

9 “(c) LIMITATION.—The Secretary shall not provide
10 funds for the operation and maintenance of the project
11 authorized by this section.

12 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
13 is authorized to be appropriated to carry out this section
14 \$875,000.”.

15 (b) PROJECT IMPLEMENTATION.—In carrying out
16 sections 1642 through 1648 of the Reclamation Waste-
17 water and Groundwater Study and Facilities Act, and the
18 sections added to such Act by subsection (a), the Secretary
19 shall enter into individual agreements to fund the projects
20 and shall include in such agreements a provision for the
21 reimbursement of design, planning, and construction
22 costs, including those costs incurred prior to the enact-
23 ment of this Act, subject to appropriations made available
24 for the Federal share of the project under sections 1642
25 through 1648 of the Reclamation Wastewater and

1 Groundwater Study and Facilities Act and the sections
2 added to such Act by subsection (a).

3 (c) CLERICAL AMENDMENTS.—The table of contents
4 of the Reclamation Projects Authorization and Adjust-
5 ment Act of 1992 (43 U.S.C. prec. 371) (as amended by
6 section 512(a) of the Consolidated Natural Resources Act
7 of 2008) is amended by adding at the end the following:
