Mr. KINZINGER of Illinois (for himself and Mr. LOEBSACK) introduced the following bill; which was referred to the Committee on Energy and Commerce

A BILL

To encourage spectrum licensees to make unused spectrum available for use by rural and smaller carriers in order to expand wireless coverage.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Rural Spectrum Acces-
5 sibility Act of 2015”.

6 **SEC. 2. EXTENSION OF LICENSES.**

7 Section 307 of the Communications Act of 1934 (47
8 U.S.C. 307) is amended by adding at the end the fol-
9 lowing:

10 “(g) EXTENSION OF LICENSES.—

1 “(1) DEFINITIONS.—

2 “(A) IN GENERAL.—For purposes of this
3 subsection—

4 “(i) the term ‘rural area’ means any
5 area other than—

6 “(I) an area described in clause
7 (i) or (ii) of section 343(a)(13)(A) of
8 the Consolidated Farm and Rural De-
9 velopment Act (7 U.S.C.
10 1991(a)(13)(A)); and

11 “(II) a city, town, or incor-
12 porated area that has a population of
13 greater than 20,000 inhabitants; and

14 “(ii) the term ‘small carrier’ means a
15 carrier with not more than 1,500 employ-
16 ees.

17 “(B) CALCULATION OF NUMBER OF EM-
18 PLOYEES.—For purposes of subparagraph
19 (A)(ii), the number of employees of a carrier
20 shall be determined in accordance with section
21 121.106 of title 13, Code of Federal Regula-
22 tions, or any successor thereto.

23 “(2) ESTABLISHMENT OF PROGRAM.—Not later
24 than 90 days after the date of enactment of the
25 Rural Spectrum Accessibility Act of 2015, the Com-

1 mission shall establish a program under which a car-
2 rier that receives a license under this section may
3 partition or disaggregate the license in order to
4 make unused spectrum available to small carriers or
5 carriers to serve rural areas.

6 “(3) EXTENSION OF LICENSE TERM.—Any car-
7 rier that receives a license under this section and
8 participates in the program established under para-
9 graph (2) shall receive a 3-year extension of the li-
10 cense granted under this section.”.
