A BILL

To require the Secretary of Homeland Security to ensure that sex offenders to be released from the custody of Immigration and Customs Enforcement are registered on sex offender registry, and relevant State, tribal, and local authorities are notified of their release, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Prevent Repeat Of-
5 fenders Act of 2015”.

1 **SEC. 2. REGISTRATION OF CERTAIN ALIENS.**

2 (a) IN GENERAL.—Subtitle A of the Sex Offender
3 Registration and Notification Act (42 U.S.C. 16901 et
4 seq.) is amended by adding at the end the following:

5 **“SEC. 132. REGISTRATION OF CERTAIN ALIENS IN CUSTODY**
6 **OF IMMIGRATION AND CUSTOMS ENFORCE-**
7 **MENT ON SEX OFFENDER REGISTRY AND NO-**
8 **TIFICATION TO STATE, TRIBAL, AND LOCAL**
9 **AUTHORITIES.**

10 “(a) REGISTRATION.—The Secretary of Homeland
11 Security shall take appropriate actions to ensure that,
12 prior to the release of an alien in the custody of United
13 States Immigration and Customs Enforcement (herein-
14 after in this section referred to as ‘ICE’) who is required
15 to register under this Act—

16 “(1) in coordination with the Attorney General,
17 such alien is registered in the National Sex Offender
18 Registry; and

19 “(2) such alien is informed of their registration
20 requirements under this Act.

21 “(b) CONDITION OF RELEASE.—The Secretary of
22 Homeland Security shall take appropriate actions to en-
23 sure that the release of an alien who is required to register
24 under this Act is conditioned on such alien’s registration
25 in each jurisdiction required by this Act.

1 “(c) NOTIFICATION OF STATE, TRIBAL, AND LOCAL
 2 AUTHORITIES.—The Secretary of Homeland Security
 3 shall take appropriate actions to ensure that the chief law
 4 enforcement officer of each State, tribal, and local juris-
 5 diction in which the alien resides and the agency respon-
 6 sible for the receipt or maintenance of sex offender reg-
 7 istration information in the State, tribal, or local jurisdic-
 8 tion in which the alien resides are promptly notified when
 9 an alien who is required to register under this Act is—

10 “(1) taken into custody by ICE;

11 “(2) released from ICE custody; or

12 “(3) removed from the United States.

13 “(d) REPORT TO CONGRESS.—Not later than 30 days
 14 after the date of the enactment of this Act the Secretary
 15 of Homeland Security shall report to Congress on the
 16 progress made in implementing the amendment made by
 17 this Act.”.

18 (b) CLERICAL AMENDMENT.—The table of sections
 19 in section 1 of the Adam Walsh Child Protection and Safe-
 20 ty Act is amended by inserting after the item relating to
 21 section 131 the following new item:

“132. Registration of certain aliens in custody of Immigration and Customs En-
 forcement on sex offender registry and notification to State,
 tribal, and local authorities.”.
