Mr. BARLETTA introduced the following bill; which was referred to the
Committee on Transportation and Infrastructure

A BILL

To amend title 49, United States Code, to prohibit limitations on certain grants due to standards for covered farm vehicles and drivers, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Local Farm Vehicle
5 Flexibility Act”.

6 **SEC. 2. GRANTS TO STATES.**

7 Chapter 311 of title 49, United States Code, is
8 amended—

9 (1) in section 31101—

1 (A) by redesignating paragraphs (2), (3),
2 and (4) as paragraphs (3), (4), and (5), respec-
3 tively; and

4 (B) by inserting after paragraph (1) the
5 following:

6 “(2) ‘covered farm vehicle’ means a motor vehi-
7 cle (including an articulated motor vehicle)—

8 “(A) that—

9 “(i) is registered or otherwise des-
10 ignated by the State for use in, or trans-
11 portation activities related to, the oper-
12 ation of farms;

13 “(ii) is equipped with a special reg-
14 istration plate or other State-issued des-
15 ignation to allow for identification of the
16 vehicle as a farm vehicle by law enforce-
17 ment personnel;

18 “(iii) is traveling in the State of reg-
19 istration or designation or in another
20 State;

21 “(iv) is operated by—

22 “(I) a farm owner or operator;

23 “(II) a ranch owner or operator;

24 or

1 “(III) an employee or family
2 member of an individual specified in
3 subclause (I) or (II);

4 “(v) is transporting to or from a farm
5 or ranch—

6 “(I) agricultural commodities;

7 “(II) livestock;

8 “(III) agricultural supplies; or

9 “(IV) machinery, including ma-
10 chinery being transported for the pur-
11 pose of performance of agricultural
12 production activity or for the purpose
13 of servicing or repairing the item
14 being transported;

15 “(vi) is not used in the operations of
16 a for-hire motor carrier;

17 “(vii) has a gross vehicle weight rat-
18 ing or gross vehicle weight, whichever is
19 greater, that is—

20 “(I) 26,001 pounds or less; or

21 “(II) greater than 26,001 pounds
22 and is traveling within the State of
23 registration or designation or within
24 150 air miles of the farm or ranch

1 with respect to which the vehicle is
 2 being operated; and

3 “(viii) is not transporting materials
 4 that require a placard; or

5 “(B) that—

6 “(i) meets the requirements under
 7 subparagraph (A) (other than clause (vi)
 8 of such subparagraph);

9 “(ii) is operated pursuant to a crop
 10 share farm lease agreement;

11 “(iii) is owned by a tenant with re-
 12 spect to that agreement; and

13 “(iv) is transporting the landlord’s
 14 portion of the crops under that agree-
 15 ment.”; and

16 (2) in section 31102—

17 (A) in subsection (b)(2)(E), by striking the
 18 period at the end and inserting a semicolon;

19 (B) by redesignating subsection (e) as sub-
 20 section (f); and

21 (C) by inserting after subsection (d) the
 22 following:

23 “(e) LIMITATION OF AUTHORITY; STATE STANDARDS
 24 FOR COVERED FARM VEHICLES AND DRIVERS.—The Sec-
 25 retary may not terminate, reduce, limit, or otherwise inter-

1 fere with the amount or timing of grants that a State is
2 otherwise eligible to receive under this title or title 23 as
3 a result of any minimum standard or exemption provided
4 by the State for a covered farm vehicle or the driver of
5 such vehicle that is less stringent than the requirements
6 for commercial motor vehicles and drivers established
7 under title 49, Code of Federal Regulations, including re-
8 quirements pertaining to—

9 “(1) controlled substances and alcohol use and
10 testing;

11 “(2) commercial driver’s licensing;

12 “(3) driver qualifications;

13 “(4) medical certifications;

14 “(5) driving and operating commercial vehicles;

15 “(6) parts and accessories for the safe oper-
16 ation of commercial vehicles;

17 “(7) the maximum hours of service of drivers;

18 “(8) vehicle inspection repair and maintenance;

19 “(9) employee safety and health standards; and

20 “(10) recordkeeping related to compliance with
21 such standards.”.
