A BILL

To amend the Congressional Budget Act of 1974 respecting
the scoring of preventive health savings.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SCORING OF PREVENTIVE HEALTH SAVINGS.**

4 Section 202 of the Congressional Budget and Im-
5 poundment Control Act of 1974 (2 U.S.C. 602) is amend-
6 ed by adding at the end the following new subsection:

7 “(h) SCORING OF PREVENTIVE HEALTH SAVINGS.—

1 “(1) DETERMINATION BY THE DIRECTOR.—

2 Upon a request by the chairman or ranking minority
3 member of the Committee on the Budget, the Com-
4 mittee on Finance, or the Committee on Health,
5 Education, Labor, and Pensions of the Senate, or by
6 the chairman or ranking minority member of the
7 Committee on the Budget, the Committee on Energy
8 and Commerce, or the Committee on Ways and
9 Means of the House of Representatives, the Director
10 shall determine if a proposed measure would result
11 in reductions in budget outlays in budgetary out-
12 years through the use of preventive health and pre-
13 ventive health services.

14 “(2) PROJECTIONS.—If the Director determines
15 that a measure would result in substantial reduc-
16 tions in budget outlays as described in paragraph
17 (1), the Director—

18 “(A) shall include, in any projection pre-
19 pared by the Director, a description and esti-
20 mate of the reductions in budget outlays in the
21 budgetary outyears and a description of the
22 basis for such conclusions; and

23 “(B) may prepare a budget projection that
24 includes some or all of the budgetary outyears,
25 notwithstanding the time periods for projections

1 described in subsection (e) and sections 308,
2 402, and 424.

3 “(3) DEFINITIONS.—As used in this sub-
4 section—

5 “(A) the term ‘preventive health’ means an
6 action that focuses on the health of the public,
7 individuals and defined populations in order to
8 protect, promote, and maintain health and
9 wellness and prevent disease, disability, and
10 premature death that is demonstrated by cred-
11 ible and publicly available evidence from epide-
12 miological projection models, clinical trials, ob-
13 servational studies in humans, longitudinal
14 studies, and meta-analysis; and

15 “(B) the term ‘budgetary outyears’ means
16 the 2 consecutive 10-year periods beginning
17 with the first fiscal year that is 10 years after
18 the budget year provided for in the most re-
19 cently agreed to concurrent resolution on the
20 budget.”.
