A BILL

To recognize that Christians and Yazidis in Iraq, Syria, Pakistan, Iran, Egypt, and Libya are targets of genocide, and to provide for the expedited processing of immigrant and refugee visas for such individuals, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Save Christians from
3 Genocide Act”.

4 **SEC. 2. DECLARATION OF POLICY.**

5 Congress—

6 (1) recognizes that Christians and Yazidis in
7 Iraq, Syria, Pakistan, Iran, Egypt, and Libya are
8 targets of genocide and encourages other nations to
9 likewise recognize the ongoing genocide and the
10 threat of genocide to these people; and

11 (2) further recognizes that such targets of
12 genocide who are seeking admission to the United
13 States as immigrants or refugees should be given
14 priority and expedited processing.

15 **SEC. 3. EMERGENCY ADMISSION OF REFUGEES AND IMMI-**
16 **GRANTS.**

17 (a) REFUGEES.—

18 (1) EMERGENCY REFUGEE SITUATION DE-
19 SCRIBED.—The persecution of Christians and
20 Yazidis in Iraq, Syria, Pakistan, Iran, Egypt, and
21 Libya constitutes an unforeseen emergency refugee
22 situation, and the admission of such persecuted indi-
23 viduals in response to that situation is of grave hu-
24 manitarian concern.

25 (2) EXPEDITED PROCESSING.—The Secretary
26 of Homeland Security shall provide for the expedited

1 processing of the visas for aliens described in para-
2 graph (3), and shall ensure that such applications
3 receive first priority among applications for refugee
4 status.

5 (3) ALIENS DESCRIBED.—An alien is described
6 in this paragraph if the alien—

7 (A) is a citizen or national of Iraq, Syria,
8 Pakistan, Iran, Egypt, or Libya, or in the case
9 of an alien having no nationality, whose country
10 of last habitual residence was Iraq, Syria, Paki-
11 stan, Iran, Egypt, or Libya;

12 (B) is a member of the Christian or Yazidi
13 community; and

14 (C) is seeking admission to the United
15 States as a refugee under section 207 of the Im-
16 migration and Nationality Act (8 U.S.C. 1157).

17 (4) QUALIFICATION AS REFUGEES.—For pur-
18 poses of qualifying as a refugee under section 101
19 of the Immigration and Nationality Act (8 U.S.C.
20 1101)—

21 (A) membership in the Christian or Yazidi
22 community shall qualify an alien described in
23 paragraph (3) as a member of a persecuted
24 group; and

1 (B) the requirement that an alien be out-
2 side any country of such person's nationality or,
3 in the case of a person having no nationality,
4 is outside any country in which such person last
5 habitually resided, shall not apply to an alien
6 described in paragraph (3).

7 (b) IMMIGRANTS.—

8 (1) EXPEDITED PROCESSING.—The Secretary
9 of Homeland Security shall provide for the expedited
10 processing of visas for the aliens described in para-
11 graph (2), and shall ensure that such applications
12 receive first priority among applications for immi-
13 grant status.

14 (2) ALIENS DESCRIBED.—An alien is described
15 in this paragraph if the alien—

16 (A) is a citizen or national of Iraq, Syria,
17 Pakistan, Iran, Egypt, Libya, or in the case of
18 an alien having no nationality, whose country of
19 last habitual residence was Iraq, Syria, Paki-
20 stan, Iran, Egypt, or Libya;

21 (B) is a member of the Christian or Yazidi
22 community; and

23 (C) is seeking admission to the United
24 States as an immigrant under subsection (a) or

1 (b) of section 203 of the Immigration and Na-
2 tionality Act (8 U.S.C. 1153).
