Mr. DUNCAN of South Carolina (for himself, Mr. WITTMAN, Mr. WALZ, and Mr. GENE GREEN of Texas) introduced the following bill; which was referred to the Committee on Natural Resources

A BILL

To amend the Pittman-Robertson Wildlife Restoration Act to modernize the funding of wildlife conservation, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Modernizing the Pitt-
5 man-Robertson Fund for Tomorrow’s Needs Act of 2016”.

6 **SEC. 2. PURPOSE.**

7 The first section of the Pittman-Robertson Wildlife
8 Restoration Act (16 U.S.C. 669) is amended by adding
9 at the end the following: “One of the purposes of this Act

1 is to extend financial and technical assistance to the
2 States for the promotion of hunting and recreational
3 shooting.”.

4 **SEC. 3. DEFINITIONS.**

5 Section 2 of the Pittman-Robertson Wildlife Restora-
6 tion Act (16 U.S.C. 669a) is amended—

7 (1) by redesignating paragraphs (2) through
8 (8) as paragraphs (4) through (10), respectively;
9 and

10 (2) by inserting after paragraph (1) the fol-
11 lowing:

12 “(2) the term ‘hunter recruitment and rec-
13 reational shooter recruitment’ means any activity or
14 project to recruit or retain hunters and recreational
15 shooters, including by—

16 “(A) using social media, marketing, adver-
17 tising, surveying, television spots, print, and
18 media;

19 “(B) providing education, mentoring, and
20 field demonstrations;

21 “(C) enhancing access for hunting and rec-
22 reational shooting, including through range con-
23 struction;

1 “(D) providing education to the public
 2 about the role of hunting and recreational
 3 shooting in funding wildlife conservation; and

4 “(E) using any other means to ensure the
 5 growth of hunting and recreational shooting, as
 6 determined by the Secretary;

7 “(3) the term ‘fiscal year’ means a period of 12
 8 consecutive months beginning on October 1 and end-
 9 ing on the succeeding September 30, except that the
 10 period for enumeration of paid hunting-license hold-
 11 ers means the fiscal year or license year of the
 12 State;”.

13 **SEC. 4. ALLOCATION AND APPORTIONMENT OF AVAILABLE**
 14 **AMOUNTS.**

15 (a) APPORTIONMENT TO STATES.—Section 4(b) of
 16 the Pittman-Robertson Wildlife Restoration Act (16
 17 U.S.C. 669c(b)) is amended—

18 (1) in the first sentence, by striking “The Sec-
 19 retary of the Interior” and inserting the following:

20 “(1) IN GENERAL.—The Secretary”;

21 (2) in the second sentence, by striking “Such
 22 apportionments” and inserting the following:

23 “(2) ADJUSTMENTS.—The apportionments de-
 24 scribed in paragraph (1)”;

25 (3) by striking the third sentence; and

1 (4) by adding at the end the following:

2 “(3) USE OF FUNDS.—

3 “(A) IN GENERAL.—Subject to subpara-
4 graph (B), amounts apportioned under this
5 subsection may be used for hunter recruitment
6 and recreational shooter recruitment.

7 “(B) LIMITATION.—A State may only
8 make an expenditure under subparagraph (A) if
9 the amount of the expenditure during the fiscal
10 year in which the expenditure is made plus the
11 amount of the expenditures for hunter recruit-
12 ment and recreational shooter recruitment
13 made during the 4 fiscal years preceding that
14 fiscal year is equal to or less than 25 percent
15 of the total amount apportioned to the State
16 under this subsection during that 5-fiscal-year
17 period.”.

18 (b) APPORTIONMENT OF CERTAIN TAXES.—Section
19 4(c) of the Pittman-Robertson Wildlife Restoration Act
20 (16 U.S.C. 669c(e)) is amended—

21 (1) in the first sentence—

22 (A) by striking “One-half” and inserting
23 the following:

24 “(1) APPORTIONMENT OF CERTAIN TAXES.—

1 “(A) IN GENERAL.—Subject to subpara-
2 graph (B), 1/2”; and

3 (B) by striking “*Provided*, That each
4 State” and inserting the following:

5 “(B) CONDITION.—The apportionment
6 made under subparagraph (A) shall be subject
7 to the condition that each State”;

8 (2) in subparagraph (A) (as so designated), by
9 striking “States:” and inserting “States.”;

10 (3) in subparagraph (B) (as so designated), by
11 striking “For the purpose” and inserting the fol-
12 lowing:

13 “(2) POPULATION DETERMINATION.—For the
14 purpose”; and

15 (4) by adding at the end the following:

16 “(3) USE OF FUNDS.—Amounts apportioned
17 under this subsection may be used for hunter re-
18 cruitment and recreational shooter recruitment.”.

19 **SEC. 5. EXPENDITURES FOR MANAGEMENT OF WILDLIFE**
20 **AREAS AND RESOURCES.**

21 Section 8 of the Pittman-Robertson Wildlife Restora-
22 tion Act (16 U.S.C. 669g) is amended—

23 (1) in subsection (a), in the third sentence, by
24 striking “and public relations”; and

1 (2) in subsection (b), in the first sentence, by
2 striking “, as a part of such program”.

3 **SEC. 6. FIREARM AND BOW HUNTER EDUCATION AND SAFE-**
4 **TY PROGRAM GRANTS.**

5 Section 10(a)(1)(A) of the Pittman-Robertson Wild-
6 life Restoration Act (16 U.S.C. 669h–1(a)(1)(A)) is
7 amended—

8 (1) in clause (iii), by striking “and” at the end;
9 and

10 (2) by adding at the end the following:

11 “(v) the enhancement of hunter re-
12 cruitment and recreational shooter recruit-
13 ment; and”.

14 **SEC. 7. MULTISTATE CONSERVATION GRANT PROGRAM.**

15 Section 11 of the Pittman-Robertson Wildlife Res-
16 toration Act (16 U.S.C. 669h–2) is amended—

17 (1) in subsection (a)(1)—

18 (A) by striking “Not more than” and in-
19 serting the following:

20 “(A) IN GENERAL.—Not more than”; and

21 (B) by adding at the end the following:

22 “(B) AVAILABILITY FOR HUNTER AND
23 RECREATIONAL SHOOTER GRANTS.—Not more
24 than \$5,000,000 of the revenues covered into
25 the fund from any tax imposed under section

1 4161(b) of the Internal Revenue Code of 1986
2 for a fiscal year shall be available to the Sec-
3 retary exclusively for making hunter recruit-
4 ment and recreational shooter recruitment
5 grants that promote a national hunting and
6 shooting sport recruitment program, including
7 related communication and outreach activi-
8 ties.”;

9 (2) in subsection (b)(3), in the matter pre-
10 ceding subparagraph (A), by striking “Inter-
11 national”;

12 (3) in subsection (c)(2)(A)(i), by inserting “or
13 to recreational shooting activities” after “wildlife”;
14 and

15 (4) in subsection (d), by inserting “or to rec-
16 reational shooting activities” after “wildlife”.
