Mr. SEAN PATRICK MALONEY of New York introduced the following bill;
which was referred to the Select Committee on Intelligence (Permanent Select)

A BILL

To direct the Director of National Intelligence to establish an integration cell to monitor and enforce the Joint Comprehensive Plan of Action, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “JCPOA Intelligence
5 Enforcement Act of 2016”.

6 **SEC. 2. JCPOA MONITORING.**

7 (a) IN GENERAL.—Not later than 90 days after the
8 date of the enactment of this Act, the Director of National
9 Intelligence shall establish an integration cell among rel-

1 evant elements of the United States intelligence commu-
2 nity to integrate intelligence related to monitoring and en-
3 forcement of the Joint Comprehensive Plan of Action
4 (hereinafter referred to as the “JCPOA”). The integration
5 cell established under this subsection shall be known as
6 the “IC Iran Integration Cell” (hereinafter referred to as
7 “the Integration Cell”).

8 (b) PRIMARY FUNCTIONS.—The primary functions of
9 the Integration Cell are—

10 (1) to coordinate and synchronize all collection
11 related to implementation of the JCPOA;

12 (2) to integrate the early warning systems of
13 intelligence agencies with respect to potential viola-
14 tions of the JCPOA; and

15 (3) to identify intelligence gaps related to moni-
16 toring of the JCPOA.

17 (c) LEADERSHIP.—

18 (1) IN GENERAL.—The Integration Cell shall be
19 headed by a member of the Senior Intelligence Serv-
20 ice, who shall report to the Director of National In-
21 telligence.

22 (2) STAFFING.—The cell may be staffed
23 through detailees, assignees, or core contractor per-
24 sonnel who would otherwise conduct such work as
25 part of their normal responsibilities.

1 (d) REPORTS.—Not later than six months after the
2 date of the enactment of this Act, and annually thereafter,
3 the Director of National Intelligence shall submit to Con-
4 gress a report on the Integration Cell that includes each
5 of the following:

6 (1) A detailed description of the activities of the
7 Integration Cell.

8 (2) An assessment of the awareness of the Inte-
9 gration Cell of Iran’s compliance with the JCPOA.

10 (3) Recommendations for better collection re-
11 garding Iran’s compliance.

12 **SEC. 3. SENSE OF CONGRESS REGARDING ESTABLISHMENT**
13 **OF JOINT INTELLIGENCE FUSION CELL.**

14 It is the sense of Congress that the intelligence com-
15 munity should establish a joint fusion cell with members
16 of the Gulf Cooperation Council to—

17 (1) combat Iran’s malevolent regional activities,
18 including Iran’s support for terrorist proxy entities,
19 such as Hezbollah;

20 (2) find and disrupt illicit transfers of weapons
21 and material, in violation of United Nations Security
22 Council Resolution 2231; and

23 (3) protect the territorial integrity of key part-
24 ner nations.

1 **SEC. 4. SENSE OF CONGRESS REGARDING JOINT UNITED**
2 **STATES-ISRAEL INTELLIGENCE COOPERA-**
3 **TION.**

4 It is the sense of Congress that—

5 (1) the Director of National Intelligence should
6 establish a United States-Israel intelligence working
7 group focused specifically on the Iranian threat; and

8 (2) such working group should meet on a reg-
9 ular basis to enhance intelligence sharing on threats,
10 including—

11 (A) Iranian support for Hezbollah and
12 other terrorist actors;

13 (B) Iranian illicit smuggling of conven-
14 tional weapons;

15 (C) monitoring and collection of intel-
16 ligence on Iran's ballistic missile and space pro-
17 grams, including its pursuit of satellite pro-
18 grams; and

19 (D) monitoring and collection of intel-
20 ligence on Iran's nuclear activities.
