A BILL

To require breast density reporting to physicians and patients by facilities that perform mammograms, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Breast Density and
5 Mammography Reporting Act of 2015”.

1 **SEC. 2. FINDINGS.**

2 The Congress finds as follows:

3 (1) The National Cancer Institute estimates
4 that 1 in 8 women in the United States will develop
5 a cancer of the breast in their lifetime.

6 (2) The Centers for Disease Control and Pre-
7 vention reports that breast cancer is the number one
8 cause of cancer death among Hispanic women, and
9 the number two cause of cancer death among White,
10 Black, Asian/Pacific Islander, and American Indian/
11 Alaska Native women.

12 (3) Individuals receiving mammograms are not
13 currently required to receive medical summaries or
14 reports from their mammogram providers which ad-
15 dress breast density or its correlation to masking the
16 presence of breast cancer on mammograms, despite
17 the fact that the radiologist interpreting the mam-
18 mogram makes an assessment of the patient's breast
19 density.

20 **SEC. 3. BREAST DENSITY REPORTING BY FACILITIES THAT**
21 **PERFORM MAMMOGRAMS TO PHYSICIANS**
22 **AND PATIENTS.**

23 (a) IN GENERAL.—Clause (ii) of section 354(f)(1)(G)
24 of the Public Health Service Act (42 U.S.C.
25 263b(f)(1)(G)) is amended—

1 (1) in each of subclauses (III) and (IV), by
2 striking “and” at the end; and

3 (2) by adding at the end the following:

4 “(V) the report under subclause (I)
5 and the summary under subclause (IV)
6 shall include information about breast den-
7 sity, as specified by the Secretary based
8 upon—

9 “(aa) current scientific knowl-
10 edge;

11 “(bb) technological advances; or

12 “(cc) other updated medical pro-
13 cedures where the use of such screen-
14 ing developments is consistent with
15 the practice of medical experts in the
16 field;

17 “(VI) the summary under subclause
18 (IV) shall convey the effect of breast den-
19 sity in masking the presence of breast can-
20 cer on mammography, using the provider’s
21 qualitative assessment of the patient’s
22 breast density; and

23 “(VII) the summary under subclause
24 (IV) shall include language, developed by
25 the Secretary in consultation with leading

1 experts and leading cancer organizations,
 2 communicating that individuals with dense
 3 breasts should talk with their physicians
 4 about—

5 “(aa) any questions or concerns
 6 regarding the summary; and

7 “(bb) whether the individuals
 8 would benefit from additional tests.”.

9 (b) RULE OF CONSTRUCTION.—This section and the
 10 amendments made by this section shall not be construed
 11 to alter in any way Federal requirements relating to finan-
 12 cial obligations of any person in connection with health
 13 insurance.

14 **SEC. 4. ENHANCING RESEARCH RELATING TO BREAST DEN-**
 15 **SITY.**

16 Title III of the Public Health Service Act is amended
 17 by inserting after section 354 of such Act (42 U.S.C.
 18 263b) the following:

19 **“SEC. 354A. ENHANCING RESEARCH RELATING TO BREAST**
 20 **DENSITY.**

21 “The Secretary shall expand and intensify the pro-
 22 grams and activities of the Department of Health and
 23 Human Services for conducting or supporting—

24 “(1) applied research on breast density;

1 “(2) research on the cost-effectiveness, effec-
2 tiveness, and feasibility of reimbursement models for
3 supplemental imaging relating to breast density; and
4 “(3) research in support of clinical guidelines
5 and best practices concerning use of mammograms
6 and supplemental screening for women with dense
7 breasts.”.
