A BILL

To amend the Workforce Innovation and Opportunity Act
to improve the Act.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “WIOA Technical
5 Amendments Act”.

6 **SEC. 2. AMENDMENTS TO WORKFORCE INNOVATION AND**
7 **OPPORTUNITY ACT.**

8 (a) LOCAL WORKFORCE DEVELOPMENT BOARDS.—
9 Section 107(i)(1)(B) of the Workforce Innovation and Op-
10 portunity Act (29 U.S.C. 3122(i)(1)(B)) is amended by

1 striking “the day before the date of enactment of this Act”
 2 and inserting “the day before the date of enactment of
 3 the Workforce Investment Act of 1998”.

4 (b) PERFORMANCE ACCOUNTABILITY SYSTEM.—Sec-
 5 tion 116 of such Act (29 U.S.C. 3141) is amended—

6 (1) in subsection (b)(2)(A)(iv), by striking
 7 “clause (i)(IV)” and inserting “clause (i)(VI)”; and

8 (2) in subsection (g), by striking “for a pro-
 9 gram described in subsection (d)(2)(A)”.

10 (c) STATE ALLOTMENTS.—Section 132(b) of such
 11 Act (29 U.S.C. 3172(b)) is amended, in paragraphs
 12 (1)(B)(iv)(I) and (2)(B)(iii)(I), by inserting “less than”
 13 after “fiscal year that is”.

14 (d) EFFECTIVE DATE.—The amendments made by
 15 this section shall take effect as if included in the Work-
 16 force Innovation and Opportunity Act.

17 **SEC. 3. ESTABLISHMENT OF NATIONAL COUNCIL ON DIS-**
 18 **ABILITY.**

19 (a) IN GENERAL.—Section 400(b) of the Rehabilita-
 20 tion Act of 1973 (29 U.S.C. 780(b)) is amended to read
 21 as follows:

22 “(b)(1) Each member of the National Council shall
 23 serve for a term of 3 years.

24 “(2)(A) No member of the National Council may
 25 serve more than two consecutive full terms beginning on

1 the date of commencement of the first full term on the
2 Council. Members may serve after the expiration of their
3 terms until their successors have taken office.

4 “(B) As used in this paragraph, the term ‘full term’
5 means a term of 3 years.

6 “(3) Any member appointed to fill a vacancy occur-
7 ring before the expiration of the term for which such mem-
8 ber’s predecessor was appointed shall be appointed only
9 for the remainder of such term.”.

10 (b) EFFECTIVE DATE.—The amendment made by
11 this section shall take effect as if enacted 1 day after the
12 date of enactment of the Workforce Innovation and Op-
13 portunity Act (29 U.S.C. 3101 et seq.).
