A BILL

To provide for certain requirements relating to the Internet
Assigned Numbers Authority stewardship transition.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Domain Openness
3 Through Continued Oversight Matters Act of 2015” or
4 the “DOTCOM Act of 2015”.

5 **SEC. 2. REQUIREMENTS FOR IANA STEWARDSHIP TRANSI-**
6 **TION.**

7 (a) IN GENERAL.—Until the date that is 30 legisla-
8 tive days after the submission to Congress of the report
9 described in subsection (b), the Assistant Secretary may
10 not permit the NTIA’s role in the performance of the
11 Internet Assigned Numbers Authority functions to termi-
12 nate, lapse, be cancelled, or otherwise cease to be in effect.

13 (b) REPORT DESCRIBED.—The report described in
14 this subsection is a report that contains—

15 (1) the proposal relating to the transition of the
16 NTIA’s stewardship of the Internet Assigned Num-
17 bers Authority functions that was developed in a
18 process convened by ICANN at the request of the
19 NTIA; and

20 (2) a certification by the Assistant Secretary
21 that—

22 (A) such proposal—

23 (i) supports and enhances the multi-
24 stakeholder model of Internet governance;

1 (ii) maintains the security, stability,
2 and resiliency of the Internet domain name
3 system;

4 (iii) meets the needs and expectations
5 of the global customers and partners of the
6 Internet Assigned Numbers Authority serv-
7 ices;

8 (iv) maintains the openness of the
9 Internet; and

10 (v) does not replace the role of the
11 NTIA with a government-led or intergov-
12 ernmental organization solution; and

13 (B) the required changes to ICANN's by-
14 laws contained in the final report of ICANN's
15 Cross Community Working Group on Enhanc-
16 ing ICANN Accountability and the changes to
17 ICANN's bylaws required by ICANN's IANA
18 Stewardship Transition Coordination Group
19 have been implemented.

20 (c) DEFINITIONS.—In this section:

21 (1) ASSISTANT SECRETARY.—The term “Assist-
22 ant Secretary” means the Assistant Secretary of
23 Commerce for Communications and Information.

1 (2) ICANN.—The term “ICANN” means the
 2 Internet Corporation for Assigned Names and Num-
 3 bers.

4 (3) LEGISLATIVE DAY.—The term “legislative
 5 day” does not include Saturdays, Sundays, legal
 6 public holidays, or days either House of Congress is
 7 adjourned for more than 3 days during a session of
 8 Congress.

9 (4) NTIA.—The term “NTIA” means the Na-
 10 tional Telecommunications and Information Admin-
 11 istration.

 4 *convened by ICANN at the request of the NTIA; and*
 5 (2) *a certification by the Assistant Secretary*
 6 *that—*

7 (A) *such proposal—*

8 (i) *supports and enhances the multi-*
 9 *stakeholder model of Internet governance;*

10 (ii) *maintains the security, stability,*
 11 *and resiliency of the Internet domain name*
 12 *system;*

13 (iii) *meets the needs and expectations*
 14 *of the global customers and partners of the*
 15 *Internet Assigned Numbers Authority serv-*
 16 *ices;*

17 (iv) *maintains the openness of the*
 18 *Internet; and*

19 (v) *does not replace the role of the*
 20 *NTIA with a government-led or intergovern-*
 21 *mental organization solution; and*

22 (B) *the required changes to ICANN’s bylaws*
 23 *contained in the final report of ICANN’s Cross*
 24 *Community Working Group on Enhancing*
 25 *ICANN Accountability and the changes to*

1 *ICANN's bylaws required by ICANN's IANA*
2 *Stewardship Transition Coordination Group*
3 *have been adopted.*

4 *(c) DEFINITIONS.—In this section:*

5 *(1) ASSISTANT SECRETARY.—The term “Assist-*
6 *ant Secretary” means the Assistant Secretary of Com-*
7 *merce for Communications and Information.*

8 *(2) ICANN.—The term “ICANN” means the*
9 *Internet Corporation for Assigned Names and Num-*
10 *bers.*

11 *(3) LEGISLATIVE DAY.—The term “legislative*
12 *day” does not include Saturdays, Sundays, legal pub-*
13 *lic holidays, or days either House of Congress is ad-*
14 *jourled for more than 3 days during a session of*
15 *Congress.*

16 *(4) NTIA.—The term “NTIA” means the Na-*
17 *tional Telecommunications and Information Admin-*
18 *istration.*
