To stop exploitation through trafficking.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Stop Exploitation
 5 Through Trafficking Act of 2015”.

1 **SEC. 2. SAFE HARBOR INCENTIVES.**

2 Part Q of title I of the Omnibus Crime Control and
3 Safe Streets Act of 1968 (42 U.S.C. 3796dd et seq.) is
4 amended—

5 (1) in section 1701(c), by striking “where fea-
6 sible” and all that follows, and inserting the fol-
7 lowing: “where feasible, to an application—

8 “(1) for hiring and rehiring additional career
9 law enforcement officers that involves a non-Federal
10 contribution exceeding the 25 percent minimum
11 under subsection (g); or

12 “(2) from an applicant in a State that has in
13 effect a law that—

14 “(A) treats a minor who has engaged in,
15 or has attempted to engage in, a commercial
16 sex act as a victim of a severe form of traf-
17 ficking in persons;

18 “(B) discourages or prohibits the charging
19 or prosecution of an individual described in sub-
20 paragraph (A) for a prostitution or sex traf-
21 ficking offense, based on the conduct described
22 in subparagraph (A); and

23 “(C) encourages the diversion of an indi-
24 vidual described in subparagraph (A) to appro-
25 priate service providers, including child welfare
26 services, victim treatment programs, child advo-

1 cacy centers, rape crisis centers, or other social
 2 services.”; and

3 (2) in section 1709, by inserting at the end the
 4 following:

5 “(5) ‘commercial sex act’ has the meaning given
 6 the term in section 103 of the Victims of Trafficking
 7 and Violence Protection Act of 2000 (22 U.S.C.
 8 7102).

9 “(6) ‘minor’ means an individual who has not
 10 attained the age of 18 years.

11 “(7) ‘severe form of trafficking in persons’ has
 12 the meaning given the term in section 103 of the
 13 Victims of Trafficking and Violence Protection Act
 14 of 2000 (22 U.S.C. 7102).”.

15 **SEC. 3. REPORT ON RESTITUTION PAID IN CONNECTION**
 16 **WITH CERTAIN TRAFFICKING OFFENSES.**

17 Section 105(d)(7)(Q) of the Victims of Trafficking
 18 and Violence Protection Act of 2000 (22 U.S.C.
 19 7103(d)(7)(Q)) is amended—

20 (1) by inserting after “1590,” the following:
 21 “1591,”;

22 (2) by striking “and 1594” and inserting
 23 “1594, 2251, 2251A, 2421, 2422, and 2423”;

24 (3) in clause (iv), by striking “and” at the end;

1 (4) in clause (v), by striking “and” at the end;

2 and

3 (5) by inserting after clause (v) the following:

4 “(vi) the number of individuals re-
5 quired by a court order to pay restitution
6 in connection with a violation of each of-
7 fense under title 18, United States Code,
8 the amount of restitution required to be
9 paid under each such order, and the
10 amount of restitution actually paid pursu-
11 ant to each such order; and

12 “(vii) the age, gender, race, country of
13 origin, country of citizenship, and descrip-
14 tion of the role in the offense of individuals
15 convicted under each offense; and”.

16 **SEC. 4. NATIONAL HUMAN TRAFFICKING HOTLINE.**

17 Section 107(b)(2) of the Victims of Trafficking and
18 Violence Protection Act of 2000 (22 U.S.C. 7105(b)(2))
19 is amended—

20 (1) by redesignating subparagraphs (B) and
21 (C) as subparagraphs (C) and (D), respectively; and
22 (2) by inserting after subparagraph (A) the fol-
23 lowing:

24 “(B) NATIONAL HUMAN TRAFFICKING
25 HOTLINE.—Beginning in fiscal year 2017 and

1 each fiscal year thereafter, of amounts made
2 available for grants under this paragraph, the

3 **SEC. 4. NATIONAL HUMAN TRAFFICKING HOTLINE.**

4 *Section 107(b)(1)(B) of the Victims of Crime Traf-*
5 *ficking and Violence Protection Act of 2000 (22 U.S.C.*
6 *7105(b)(1)(B)) is amended—*

7 *(1) by striking “Subject” and inserting “(i) IN*
8 *GENERAL.—Subject”; and*

9 *(2) by adding at the end the following:*

10 “(i) *NATIONAL HUMAN TRAFFICKING*
11 *HOTLINE.—Beginning in fiscal year 2017*
12 *and each fiscal year thereafter, of amounts*
13 *made available for grants under paragraph*
14 *(2), the Secretary of Health and Human*
15 *Services shall make grants for a national*
16 *communication system to assist victims of*
17 *severe forms of trafficking in persons in*
18 *communicating with service providers. The*
19 *Secretary shall give priority to grant appli-*
20 *cants that have experience in providing*
21 *telephone services to victims of severe*
22 *forms of trafficking in persons.”.*

1 **SEC. 5. JOB CORPS ELIGIBILITY.**

2 Section 144(a)(3) of the Workforce Innovation and
3 Opportunity Act (29 U.S.C. 3194(a)(3)) is amended by
4 adding at the end the following:

5 “(F) A victim of a severe form of traf-
6 ficking in persons (as defined in section 103 of
7 the Victims of Trafficking and Violence Protec-
8 tion Act of 2000 (22 U.S.C. 7102)). Notwith-
9 standing paragraph (2), an individual described
10 in this subparagraph shall not be required to
11 demonstrate eligibility under such paragraph.”.

12 **SEC. 6. CLARIFICATION OF AUTHORITY OF THE UNITED**
13 **STATES MARSHALS SERVICE.**

14 Section 566(e)(1) of title 28, United States Code, is
15 amended—

16 (1) in subparagraph (B), by striking “and” at
17 the end;

18 (2) in subparagraph (C), by striking the period
19 at the end and inserting “; and”; and

20 (3) by inserting after subparagraph (C), the fol-
21 lowing:

22 “(D) assist State, local, and other Federal
23 law enforcement agencies, upon the request of
24 such an agency, in locating and recovering
25 missing children.”.

1 **SEC. 7. ESTABLISHING A NATIONAL STRATEGY TO COMBAT**
2 **HUMAN TRAFFICKING.**

3 (a) IN GENERAL.—The Attorney General shall imple-
4 ment and maintain a National Strategy for Combating
5 Human Trafficking (referred to in this section as the “Na-
6 tional Strategy”) in accordance with this section.

7 (b) REQUIRED CONTENTS OF NATIONAL STRAT-
8 EGY.—The National Strategy shall include the following:

9 (1) Integrated Federal, State, local, and tribal
10 efforts to investigate and prosecute human traf-
11 ficking cases, including—

12 (A) the development by each United States
13 attorney, in consultation with State, local, and
14 tribal government agencies, of a district-specific
15 strategic plan to coordinate the identification of
16 victims and the investigation and prosecution of
17 human trafficking crimes;

18 (B) the appointment of not fewer than 1
19 assistant United States attorney in each district
20 dedicated to the prosecution of human traf-
21 ficking cases or responsible for implementing
22 the National Strategy;

23 (C) the participation in any Federal, State,
24 local, or tribal human trafficking task force op-
25 erating in the district of the United States at-
26 torney; and

1 (D) any other efforts intended to enhance
2 the level of coordination and cooperation, as de-
3 termined by the Attorney General.

4 (2) Case coordination within the Department of
5 Justice, including specific integration, coordination,
6 and collaboration, as appropriate, on human traf-
7 ficking investigations between and among the United
8 States attorneys, the Human Trafficking Prosecu-
9 tion Unit, the Child Exploitation and Obscenity Sec-
10 tion, and the Federal Bureau of Investigation.

11 (3) Annual budget priorities and Federal efforts
12 dedicated to preventing and combating human traf-
13 ficking, including resources dedicated to the Human
14 Trafficking Prosecution Unit, the Child Exploitation
15 and Obscenity Section, the Federal Bureau of Inves-
16 tigation, and all other entities that receive Federal
17 support that have a goal or mission to combat the
18 exploitation of adults and children.

19 (4) An ongoing assessment of the future trends,
20 challenges, and opportunities, including new inves-
21 tigative strategies, techniques, and technologies, that
22 will enhance Federal, State, local, and tribal efforts
23 to combat human trafficking.

24 (5) Encouragement of cooperation, coordina-
25 tion, and mutual support between private sector and

1 other entities and organizations and Federal agen-
2 cies to combat human trafficking, including the in-
3 volvement of State, local, and tribal government
4 agencies to the extent Federal programs are in-
5 volved.
