A BILL

To direct the Federal Communications Commission to extend to private land use restrictions its rule relating to reasonable accommodation of amateur service communications.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Amateur Radio Parity
5 Act of 2015”.

1 **SEC. 2. FINDINGS.**

2 Congress finds the following:

3 (1) More than 700,000 radio amateurs in the
4 United States are licensed by the Federal Commu-
5 nications Commission in the amateur radio service.

6 (2) Amateur radio, at no cost to taxpayers, pro-
7 vides a fertile ground for technical self-training in
8 modern telecommunications, electronics technology,
9 and emergency communications techniques and pro-
10 tocols.

11 (3) There is a strong Federal interest in the ef-
12 fective performance of amateur radio stations estab-
13 lished at the residences of licensees. Such stations
14 have been shown to be frequently and increasingly
15 precluded by unreasonable private land use restric-
16 tions, including restrictive covenants.

17 (4) Federal Communications Commission regu-
18 lations have for 3 decades prohibited the application
19 to amateur radio stations of State and local regula-
20 tions that preclude or fail to reasonably accommo-
21 date amateur service communications, or that do not
22 constitute the minimum practicable regulation to ac-
23 complish a legitimate State or local purpose. Com-
24 mission policy has been and is to permit erection of
25 a station antenna structure at heights and dimen-

1 sions sufficient to accommodate amateur service
2 communications.

3 (5) The Federal Communications Commission
4 has sought guidance and direction from Congress
5 with respect to the application of the Commission's
6 limited preemption policy regarding amateur radio
7 communications to private land use restrictions, in-
8 cluding restrictive covenants.

9 **SEC. 3. ACCOMMODATION OF AMATEUR SERVICE COMMU-**
10 **NICATIONS.**

11 Not later than 120 days after the date of the enact-
12 ment of this Act, the Federal Communications Commis-
13 sion shall amend section 97.15(b) of title 47, Code of Fed-
14 eral Regulations, so that such section prohibits application
15 to amateur service communications of any private land use
16 restriction, including a restrictive covenant, that—

17 (1) precludes such communications;

18 (2) fails to reasonably accommodate such com-
19 munications; or

20 (3) does not constitute the minimum practicable
21 restriction on such communications to accomplish
22 the legitimate purpose of the private entity seeking
23 to enforce such restriction.
