## A BILL

To improve defense cooperation between the United States  
and the Hashemite Kingdom of Jordan.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “United States-Jordan  
5       Defense Cooperation Act of 2015”.

1   **SEC. 2. FINDINGS.**

2       Congress makes the following findings:

3               (1) As of January 22, 2015, the United States  
4       Government has provided \$3,046,343,000 in assist-  
5       ance to respond to the Syria humanitarian crisis, of  
6       which nearly \$467,000,000 has been provided to the  
7       Hashemite Kingdom of Jordan.

8               (2) As of January 2015, according to the  
9       United Nations High Commissioner for Refugees,  
10      there were 621,937 registered Syrian refugees in  
11      Jordan and 83.8 percent of whom lived outside ref-  
12      ugee camps.

13               (3) In 2000, the United States and Jordan  
14      signed a free-trade agreement that went into force  
15      in 2001.

16               (4) In 1996, the United States granted Jordan  
17      major non-NATO ally status.

18               (5) Jordan is suffering from the Syrian refugee  
19       crisis and the threat of the Islamic State of Iraq and  
20       the Levant (ISIL).

21               (6) The Government of Jordan was elected as  
22       a non-permanent member of the United Nations Se-  
23       curity Council for a 2-year term ending in December  
24       2015.

25               (7) Enhanced support for defense cooperation  
26       with Jordan is important to the national security of

1       the United States, including through creation of a  
2       status in law for Jordan similar to the countries in  
3       the North Atlantic Treaty Organization, Japan,  
4       Australia, the Republic of Korea, Israel, and New  
5       Zealand, with respect to consideration by Congress  
6       of foreign military sales to Jordan.

7                 (8) The Colorado National Guard's relationship  
8       with the Jordanian military provides a significant  
9       benefit to both the United States and Jordan.

10               (9) Jordanian pilot Moaz al-Kasasbeh was bru-  
11       tally murdered by ISIL.

12               (10) On February 3, 2015, Secretary of State  
13       John Kerry and Jordanian Foreign Minister Nasser  
14       Judeh signed a new Memorandum of Understanding  
15       that reflects the intention to increase United States  
16       assistance to the Government of Jordan from  
17       \$660,000,000 to \$1,000,000,000 for each of the  
18       years 2015 through 2017.

19 **SEC. 3. STATEMENT OF POLICY.**

20       It should be the policy of the United States—

21               (1) to support the Hashemite Kingdom of Jor-  
22       dan in its response to the Syrian refugee crisis;

23               (2) to provide necessary assistance to alleviate  
24       the domestic burden to provide basic needs for the  
25       assimilated Syrian refugees;

1                         (3) to cooperate with Jordan to combat the ter-  
2                         rorist threat from the Islamic State of Iraq and the  
3                         Levant (ISIL) or other terrorist organizations; and  
4                         (4) to help secure the border between Jordan  
5                         and its neighbors Syria and Iraq.

6 **SEC. 4. SENSE OF CONGRESS.**

7                         It is the sense of Congress that expeditious consider-  
8                         ation of certifications of letters of offer to sell defense arti-  
9                         cles, defense services, design and construction services,  
10                         and major defense equipment to the Hashemite Kingdom  
11                         of Jordan under section 36(b) of the Arms Export Control  
12                         Act (22 U.S.C. 2776(b)) is fully consistent with United  
13                         States security and foreign policy interests and the objec-  
14                         tives of world peace and security.

15 **SEC. 5. ENHANCED DEFENSE COOPERATION.**

16                         (a) IN GENERAL.—During the 3-year period begin-  
17                         ning on the date of the enactment of this Act, the  
18                         Hashemite Kingdom of Jordan shall be treated as if it  
19                         were a country listed in the provisions of law described  
20                         in subsection (b) for purposes of applying and admin-  
21                         istering such provisions of law.

22                         (b) ARMS EXPORT CONTROL ACT.—The provisions  
23                         of law described in this subsection are—

1                             (1) subsections (b)(2), (d)(2)(B), (d)(3)(A)(i),  
2                             and (d)(5) of section 3 of the Arms Export Control  
3                             Act (22 U.S.C. 2753);  
4                             (2) subsections (e)(2)(A), (h)(1)(A), and (h)(2)  
5                             of section 21 of such Act (22 U.S.C. 2761);  
6                             (3) subsections (b)(1), (b)(2), (b)(6), (c), and  
7                             (d)(2)(A) of section 36 of such Act (22 U.S.C.  
8                             2776);  
9                             (4) section 62(c)(1) of such Act (22 U.S.C.  
10                             2796a(c)(1)); and  
11                             (5) section 63(a)(2) (22 U.S.C. 2796b(a)(2)).

12 **SEC. 6. MEMORANDUM OF UNDERSTANDING.**

13                             Subject to the availability of appropriations, the Sec-  
14                             retary of State is authorized to enter into a memorandum  
15                             of understanding with the Hashemite Kingdom of Jordan  
16                             to increase economic support funds, military cooperation,  
17                             including joint military exercises, personnel exchanges,  
18                             support for international peacekeeping missions, and en-  
19                             hanced strategic dialogue.
