Mr. MCCAIN introduced the following bill; which was read twice and referred to the Committee on Veterans' Affairs

A BILL

To eliminate the sunset date for the Choice Program of the Department of Veterans Affairs, to expand eligibility for such program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Permanent Depart-
5 ment of Veterans Affairs Choice Card Act of 2015”.

6 **SEC. 2. EXPANSION OF CHOICE PROGRAM OF DEPARTMENT**
7 **OF VETERANS AFFAIRS.**

8 (a) ELIMINATION OF SUNSET.—

1 (1) IN GENERAL.—Section 101 of the Veterans
2 Access, Choice, and Accountability Act of 2014
3 (Public Law 113–146; 38 U.S.C. 1701 note) is
4 amended—

5 (A) by striking subsection (p); and

6 (B) by redesignating subsections (q), (r),
7 (s), and (t) as subsections (p), (q), (r), and (s),
8 respectively.

9 (2) CONFORMING AMENDMENTS.—Such section
10 is amended—

11 (A) in subsection (i)(2), by striking “dur-
12 ing the period in which the Secretary is author-
13 ized to carry out this section pursuant to sub-
14 section (p)”;

15 (B) in subsection (p)(2), as redesignated
16 by paragraph (1)(B), by striking subparagraph
17 (F).

18 (b) EXPANSION OF ELIGIBILITY.—

19 (1) IN GENERAL.—Subsection (b) of such sec-
20 tion is amended to read as follows:

21 “(b) ELIGIBLE VETERANS.—A veteran is an eligible
22 veteran for purposes of this section if the veteran is en-
23 rolled in the patient enrollment system of the Department
24 of Veterans Affairs established and operated under section
25 1705 of title 38, United States Code, including any such

1 veteran who has not received hospital care or medical serv-
 2 ices from the Department and has contacted the Depart-
 3 ment seeking an initial appointment from the Department
 4 for the receipt of such care or services.”.

5 (2) CONFORMING AMENDMENTS.—Such section
 6 is amended—

7 (A) in subsection (c)(1)—

8 (i) in the matter preceding subpara-
 9 graph (A), by striking “In the case of an
 10 eligible veteran described in subsection
 11 (b)(2)(A), the Secretary shall, at the elec-
 12 tion of the eligible veteran” and inserting
 13 “The Secretary shall, at the election of an
 14 eligible veteran”; and

15 (ii) in subparagraph (A), by striking
 16 “described in such subsection” and insert-
 17 ing “of the Veterans Health Administra-
 18 tion”;

19 (B) in subsection (f)(1), by striking “sub-
 20 section (b)(1)” and inserting “subsection (b)”;

21 (C) in subsection (g), by striking para-
 22 graph (3); and

23 (D) in subsection (p)(2)(A), as redesign-
 24 nated by subsection (a)(1)(B), by striking “,

1 disaggregated by—” and all that follows
2 through “subsection (b)(2)(D)”.

3 (c) EFFECTIVE DATE.—The amendments made by
4 this section shall apply with respect to hospital care and
5 medical services furnished under such section on and after
6 the date that is 90 days after the date of the enactment
7 of this Act.
