Mr. HELLER (for himself, Mr. BENNET, and Mr. BLUNT) introduced the following bill; which was read twice and referred to the Committee on Finance

A BILL

To amend title XVIII of the Social Security Act to strengthen intensive cardiac rehabilitation programs under the Medicare program.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Strengthening Medi-
5 care Intensive Cardiac Rehabilitation Programs Act of
6 2015”.

7 **SEC. 2. REVISED REQUIREMENTS FOR MEDICARE INTEN-**
8 **SIVE CARE REHABILITATION PROGRAMS.**

9 Section 1861(eee)(4) of the Social Security Act (42
10 U.S.C. 1395x(eee)(4)) is amended—

1 (1) in subparagraph (A)—

2 (A) in the matter preceding clause (i)—

3 (i) by striking “physician-supervised
4 program (as described in paragraph (2))”
5 and inserting “program (supervised as de-
6 scribed in paragraph (2))”; and

7 (ii) by striking “, in peer-reviewed
8 published research, that it accomplished”
9 and inserting “in peer-reviewed published
10 research of its own program, that by life-
11 style changes alone it accomplished”;

12 (B) in clause (i)—

13 (i) in subclause (I), by striking “posi-
14 tively affected” and inserting “reversed”;

15 (ii) in subclause (II), by striking “or”
16 and inserting “and”; and

17 (iii) by striking subclause (III);

18 (C) in clause (ii), in the matter preceding
19 subclause (I), by inserting “both a statistically
20 significant increase in the measure of blood flow
21 to the heart when compared to a control group
22 and” before “a statistically significant”; and

23 (D) by adding at the end the following new
24 sentence:

1 “Programs that the Secretary approved under this para-
 2 graph before August 1, 2015, as intensive cardiac rehabili-
 3 tation programs according to the requirements under this
 4 subparagraph before the date of the enactment of the
 5 Strengthening Medicare Intensive Cardiac Rehabilitation
 6 Programs Act of 2015 shall be deemed to meet the re-
 7 quirements under this subparagraph applied pursuant to
 8 the amendments made by such Act.”; and

9 (2) in subparagraph (B)—

10 (A) in clause (v), by striking at the end
 11 “or”;

12 (B) in clause (vi), by striking at the end
 13 the period; and

14 (C) by adding at the end the following new
 15 clauses:

16 “(vii) stable, chronic heart failure (defined
 17 as patients with left ventricular ejection fraction
 18 of 35 percent or less and New York Heart As-
 19 sociation (NYHA) class II to IV symptoms de-
 20 spite being on optimal heart failure therapy for
 21 at least 6 weeks); or

22 “(viii) any additional condition for which
 23 the Secretary has determined that a cardiac re-
 24 habilitation program shall be covered.”.
