## CONCURRENT RESOLUTION

Directing the Joint Committee on the Library to accept a statue commemorating the Hungarian Revolution of 1956 for placement in the United States Capitol, authorizing the use of the rotunda of the Capitol for a ceremony for the presentation of the statue, and directing the Architect of the Capitol to place the statue in a suitable permanent location in the Capitol.

1 **SECTION 1. ACCEPTANCE AND PLACEMENT OF STATUE**  
 2 **COMMEMORATING HUNGARIAN REVOLUTION**  
 3 **OF 1956.**

4 (a) ACCEPTANCE.—The Joint Committee on the Li-  
 5 brary shall accept for placement in the United States Cap-  
 6 itol the “Lads of Pest” statue provided by Hungary to  
 7 commemorate the heroes of the Hungarian Revolution of  
 8 1956 on the occasion of the Revolution’s 60th anniversary.

9 (b) PRESENTATION CEREMONY.—On such date fol-  
 10 lowing the acceptance of the statue under subsection (a)  
 11 as the Joint Committee on the Library determines to be  
 12 appropriate, the Joint Committee is authorized to use the  
 13 rotunda of the Capitol for a presentation ceremony for the  
 14 statue. The Architect of the Capitol and the Capitol Police  
 15 Board shall take such action as may be necessary with  
 16 respect to physical preparations and security for the cere-  
 17 mony.

18 (c) PLACEMENT.—

19 (1) INITIAL PLACEMENT IN ROTUNDA.—During  
 20 a period not to exceed one year beginning on the  
 21 date of the presentation ceremony under subsection  
 22 (b), the Architect of the Capitol shall place the stat-  
 23 ue accepted under this section in the rotunda of the  
 24 Capitol.

25 (2) PERMANENT PLACEMENT.—After the expi-  
 26 ration of the period described in paragraph (1), the

- 1 Architect of the Capitol shall provide for the place-
- 2 ment of the statue in a suitable permanent location
- 3 in the United States Capitol.
