A BILL

To amend the Balanced Budget and Emergency Deficit Control Act of 1985 to eliminate the sequestration for the revised security category under section 251 and to eliminate the section 251A reduction in discretionary appropriations and direct spending accounts within function 050 (defense).

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Repeal Sequestration
5 for Defense Act”.

1 **SEC. 2. ELIMINATION OF SEQUESTRATION UNDER THE RE-**
2 **VED SECURITY CATEGORY.**

3 Section 251(c)(1) of the Balanced Budget and Emer-
4 gency Deficit Control Act of 1985 is amended by striking
5 each subparagraph (A) for fiscal years 2014 through 2021
6 and by redesignating each subparagraph (B) as subpara-
7 graph (A).

8 **SEC. 3. ELIMINATION OF SECTION 251A REDUCTION IN DIS-**
9 **CRETIONARY APPROPRIATIONS AND DIRECT**
10 **SPENDING ACCOUNTS FOR DEFENSE.**

11 Section 251A of the Balanced Budget and Emer-
12 gency Deficit Control Act of 1985 is amended as follows:

13 (1) In paragraph (1)(D), strike “9” and insert
14 “18”.

15 (2) In paragraph (2), strike everything after
16 “section 254(c),” and insert the following: “OMB
17 shall allocate the total reduction calculated pursuant
18 to paragraph (1) for that year to discretionary ap-
19 propriations and direct spending accounts except for
20 function 050 (defense function).”.

21 (3) Strike paragraph (3).

22 (4) In paragraph (5)(B), strike the dash after
23 “limit”, strike clause (i), and strike “(ii)” and move
24 that text 2 ems to the left.

25 (5) In paragraph (6)(A), strike “paragraphs (3)
26 and (4)” and insert “paragraph (4)”.

- 1 (6) In paragraph (6)(B), strike the dash after
- 2 “that”, strike clause (i), and strike “(ii)” and move
- 3 that text 2 ems to the left.
