## A BILL

To require the Secretary of the Treasury to mint coins in commemoration of the National Purple Heart Hall of Honor.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1   **SECTION 1. SHORT TITLE.**

2       This Act may be cited as the “National Purple Heart  
3   Hall of Honor Commemorative Coin Act”.

4   **SEC. 2. FINDINGS.**

5       The Congress finds the following:

6           (1) The National Purple Heart Hall of Honor’s  
7   mission is—

8               (A) to commemorate the extraordinary sac-  
9   rifice of America’s servicemen and service-  
10   women who were killed or wounded in combat;  
11   and

12               (B) to collect and preserve the stories of  
13   National Purple Heart recipients from all  
14   branches of service and across generations to  
15   ensure that all recipients are represented.

16               (2) The National Purple Heart Hall of Honor  
17   first opened its doors on November 10, 2006, in  
18   New Windsor, NY.

19               (3) The National Purple Heart Hall of Honor  
20   is located at the New Windsor Cantonment State  
21   Historic Site, where General George Washington’s  
22   Army camped during the Revolutionary War and  
23   where he first awarded the Badge of Military Merit,  
24   a piece of purple cloth that became the model for the  
25   Purple Heart.

1                             (4) The National Purple Heart Hall of Honor  
2        is the first to recognize the more than 1.7 million  
3        U.S. servicemembers wounded or killed in action  
4        ranging from the American Revolutionary War to  
5        the present day, serving as a living memorial to their  
6        sacrifice by sharing their stories through interviews,  
7        exhibits and the Roll of Honor, an interactive com-  
8        puter database of each recipient.

9 **SEC. 3. COIN SPECIFICATIONS.**

10                             (a) DENOMINATIONS.—The Secretary of the Treas-  
11        ury (hereafter in this Act referred to as the “Secretary”)  
12        shall mint and issue the following coins:

13                             (1) \$5 GOLD COINS.—Not more than 50,000 \$5  
14        coins, which shall—

15                                 (A) weigh 8.359 grams;  
16                                 (B) have a diameter of 0.850 inches; and  
17                                 (C) contain 90 percent gold and 10 percent  
18        alloy.

19                             (2) \$1 SILVER COINS.—Not more than 400,000  
20        \$1 coins, which shall—

21                                 (A) weigh 26.73 grams;  
22                                 (B) have a diameter of 1.500 inches; and  
23                                 (C) contain not less than 90 percent silver.

24                             (3) HALF-DOLLAR CLAD COINS.—Not more  
25        than 750,000 half-dollar coins which shall—

1                             (A) weigh 11.34 grams;  
2                             (B) have a diameter of 1.205 inches; and  
3                             (C) be minted to the specifications for half-  
4                             dollar coins contained in section 5112(b) of title  
5                             31, United States Code.

6                         (b) **LEGAL TENDER.**—The coins minted under this  
7     Act shall be legal tender, as provided in section 5103 of  
8     title 31, United States Code.

9                         (c) **NUMISMATIC ITEMS.**—For purposes of section  
10    5134 of title 31, United States Code, all coins minted  
11    under this Act shall be considered to be numismatic items.

**12 SEC. 4. DESIGN OF COINS.**

13                         (a) **DESIGN REQUIREMENTS.**—

14                         (1) **IN GENERAL.**—The design of the coins  
15     minted under this Act shall be emblematic of the  
16     National Purple Heart Hall of Honor.

17                         (2) **DESIGNATION AND INSCRIPTIONS.**—On  
18     each coin minted under this Act there shall be—

19                         (A) a designation of the value of the coin;  
20                         (B) an inscription of the year “2020”; and  
21                         (C) inscriptions of the words “Liberty”,  
22                         “In God We Trust”, “United States of Amer-  
23                         ica”, and “E Pluribus Unum”.

24                         (b) **SELECTION.**—The design for the coins minted  
25     under this Act shall be—

1                             (1) selected by the Secretary after consultation  
2                             with the Commission of Fine Arts and the National  
3                             Purple Heart Hall of Honor, Inc.; and  
4                             (2) reviewed by the Citizens Coinage Advisory  
5                             Committee.

6 **SEC. 5. ISSUANCE OF COINS.**

7                             (a) QUALITY OF COINS.—Coins minted under this  
8 Act shall be issued in uncirculated and proof qualities.

9                             (b) MINT FACILITY.—Only the West Point Mint may  
10 be used to strike any particular quality of the coins minted  
11 under this Act.

12                             (c) PERIOD FOR ISSUANCE.—The Secretary may  
13 issue coins minted under this Act only during the 1-year  
14 period beginning on January 1, 2020.

15 **SEC. 6. SALE OF COINS.**

16                             (a) SALE PRICE.—The coins issued under this Act  
17 shall be sold by the Secretary at a price equal to the sum  
18 of—

19                                 (1) the face value of the coins;  
20                                 (2) the surcharge provided in section 7(a) with  
21                                 respect to such coins; and

22                                 (3) the cost of designing and issuing the coins  
23                                 (including labor, materials, dies, use of machinery,  
24                                 overhead expenses, marketing, and shipping).

1       (b) BULK SALES.—The Secretary shall make bulk  
2 sales of the coins issued under this Act at a reasonable  
3 discount.

4       (c) PREPAID ORDERS.—

5           (1) IN GENERAL.—The Secretary shall accept  
6 prepaid orders for the coins minted under this Act  
7 before the issuance of such coins.

8           (2) DISCOUNT.—Sale prices with respect to pre-  
9 paid orders under paragraph (1) shall be at a rea-  
10 sonable discount.

11 **SEC. 7. SURCHARGES.**

12       (a) IN GENERAL.—All sales of coins issued under this  
13 Act shall include a surcharge of—

14           (1) \$35 per coin for the \$5 coin;  
15           (2) \$10 per coin for the \$1 coin; and  
16           (3) \$5 per coin for the half-dollar coin.

17       (b) DISTRIBUTION.—Subject to section 5134(f)(1) of  
18 title 31, United States Code, all surcharges received by  
19 the Secretary from the sale of coins issued under this Act  
20 shall be promptly paid by the Secretary to the National  
21 Purple Heart Hall of Honor, Inc., to help finance the con-  
22 struction of a new building and renovation of existing Na-  
23 tional Purple Heart Hall of Honor facilities.

24       (c) AUDITS.—The National Purple Heart Hall of  
25 Honor, Inc., shall be subject to the audit requirements of

1 section 5134(f)(2) of title 31, United States Code, with  
2 regard to the amounts received under subsection (b).

3 (d) LIMITATION.—Notwithstanding subsection (a),  
4 no surcharge may be included with respect to the issuance  
5 under this Act of any coin during a calendar year if, as  
6 of the time of such issuance, the issuance of such coin  
7 would result in the number of commemorative coin pro-  
8 grams issued during such year to exceed the annual 2  
9 commemorative coin program issuance limitation under  
10 section 5112(m)(1) of title 31, United States Code (as in  
11 effect on the date of the enactment of this Act). The Sec-  
12 retary of the Treasury may issue guidance to carry out  
13 this subsection.
