A BILL

To amend the Secure Rural Schools and Community Self-Determination Act of 2000 to modify the appointment and composition of resource advisory committees.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “RAC Reform Act of
5 2017”.

1 **SEC. 2. COMPOSITION AND APPOINTMENT OF RESOURCE**
2 **ADVISORY COMMITTEES.**

3 (a) IN GENERAL.—Section 205 of the Secure Rural
4 Schools and Community Self-Determination Act of 2000
5 (16 U.S.C. 7125) is amended—

6 (1) in subsection (a)—

7 (A) in paragraph (1), by striking “The
8 Secretary concerned” and inserting “The appli-
9 cable department official”; and

10 (B) in paragraph (3) by striking “the Sec-
11 retary concerned” and inserting “the applicable
12 department official”;

13 (2) in subsection (b)(6), by striking “the Sec-
14 retary concerned” and inserting “the applicable de-
15 partment official”;

16 (3) in subsection (c)—

17 (A) in the subsection heading, by striking
18 “BY THE SECRETARY” and inserting “BY THE
19 APPLICABLE DEPARTMENT OFFICIAL”;

20 (B) in paragraph (1)—

21 (i) in subparagraph (A), by striking
22 “The Secretary concerned,” and inserting
23 “Except as provided in subparagraph (C),
24 the applicable department official”;

25 (ii) in subparagraph (B), by striking
26 “The Secretary concerned” and inserting

1 “Except as provided in subparagraph (C),
2 the applicable department official”; and

3 (iii) by adding at the end the fol-
4 lowing new subparagraph:

5 “(C) EXCEPTION.—For purposes of apply-
6 ing the 4-year term limit under subparagraphs
7 (A) and (B) to a member of a resource advisory
8 committee, the applicable department official
9 shall not count as a year of the member’s term
10 any year of service the majority of which was
11 served during a fiscal year for which the budget
12 of the resource advisory committee was less
13 than \$1,000,000.”;

14 (C) in paragraph (2), by striking “The
15 Secretary concerned” and inserting “The appli-
16 cable department official”;

17 (D) in paragraph (4), by striking “The
18 Secretary concerned” and inserting “The appli-
19 cable department official”; and

20 (E) by adding at the end the following new
21 paragraph:

22 “(6) APPLICABLE DEPARTMENT OFFICIAL DE-
23 FINED.—In this section, the term ‘applicable depart-
24 ment official’ means—

1 “(A) with respect to Federal land de-
 2 scribed in section 3(7)(A), the applicable Re-
 3 gional Forester; and

4 “(B) with respect to Federal land de-
 5 scribed in section 3(7)(B), the applicable Bu-
 6 reau of Land Management State Director.”;

7 (4) in subsection (d)—

8 (A) in paragraph (1), by striking “15
 9 members” and inserting “9 members”;

10 (B) in paragraph (2), by striking “5 per-
 11 sons” each place it appears and inserting “3
 12 persons”; and

13 (C) by striking “the Secretary concerned”
 14 both places it appears and inserting “the appli-
 15 cable department official”; and

16 (5) in subsection (f)—

17 (A) by striking “the Secretary concerned”
 18 and inserting “the applicable department offi-
 19 cial”; and

20 (B) by striking “the Secretary” and insert-
 21 ing “the applicable department official”.

22 (b) CONFORMING AMENDMENT.—Section 201(3)(A)
 23 of the Secure Rural Schools and Community Self-Deter-
 24 mination Act of 2000 (16 U.S.C. 7121(3)(A)) is amended

- 1 by inserting “or applicable department official (as defined
- 2 in section 205(c)(6))” after “Secretary concerned”.
