A BILL

To amend title XVIII of the Social Security Act to reduce the occurrence of diabetes in Medicare beneficiaries by extending coverage under Medicare for medical nutrition therapy services to such beneficiaries with pre-diabetes or with risk factors for developing type 2 diabetes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Preventing Diabetes
3 in Medicare Act of 2017”.

4 **SEC. 2. FINDINGS.**

5 Congress finds the following:

6 (1) According to the Centers for Disease Con-
7 trol and Prevention, there are 86,000,000 adults
8 with pre-diabetes in the United States. The Centers
9 estimates that 51 percent of adults who are 65 years
10 of age or older have pre-diabetes. More than 90 per-
11 cent of adults with pre-diabetes are unaware they
12 have it.

13 (2) For a significant number of people with
14 pre-diabetes, early intervention can reverse elevated
15 blood glucose levels to normal range and prevent di-
16 abetes and its complications completely or can sig-
17 nificantly delay its onset. According to the Institute
18 for Alternative Futures, if 50 percent of adults with
19 pre-diabetes were able to successfully make lifestyle
20 changes proven to prevent or delay diabetes, then by
21 2025 approximately 4,700,000 new cases of diabetes
22 could be prevented at a cost savings of \$300 billion.

23 (3) Nearly 1-in-5 hospitalizations in 2008 were
24 related to diabetes according to the Agency for
25 Healthcare Research and Quality.

1 (4) Preventing diabetes and its complications
2 can save money and lives. The average annual cost
3 to treat someone with diabetes is \$13,741, compared
4 to \$3,495 for someone who does not have diabetes.
5 One out of every three Medicare dollars is spent on
6 diabetes.

7 (5) Diabetes is unique because its complications
8 and their associated health care costs are often pre-
9 ventable with currently available medical treatment
10 and lifestyle changes.

11 (6) In 2002, the Diabetes Prevention Program
12 study conducted by the National Institutes of Health
13 found that participants (all of whom were at in-
14 creased risk of developing type 2 diabetes) who made
15 lifestyle changes reduced their risk of developing
16 type 2 diabetes by 58 percent and that participants
17 who are 60 years of age or older reduced their risk
18 of developing diabetes by 71 percent.

19 (7) The Agency for Healthcare Research and
20 Quality has demonstrated that \$2,500,000,000 in
21 hospitalization costs related to the treatment of dia-
22 betes or complications resulting from diabetes could
23 be saved by providing seniors with appropriate pri-
24 mary care to prevent the onset of diabetes.

1 (8) The Medicare program currently provides
2 coverage for screening and identifying beneficiaries
3 with pre-diabetes but does not provide adequate
4 services to such beneficiaries to help them prevent or
5 delay the onset of diabetes.

6 **SEC. 3. MEDICARE COVERAGE OF MEDICAL NUTRITION**

7 **THERAPY SERVICES FOR PEOPLE WITH PRE-**
8 **DIABETES AND RISK FACTORS FOR DEVEL-**
9 **OPING TYPE 2 DIABETES.**

10 (a) IN GENERAL.—Section 1861 of the Social Secu-
11 rity Act (42 U.S.C. 1395x) is amended—

12 (1) in subsection (s)(2)(V), by striking “a bene-
13 ficiary with diabetes or a renal disease” and insert-
14 ing “an individual with diabetes, pre-diabetes (as de-
15 fined in subsection (yy)(4)), or a renal disease, or an
16 individual at risk for diabetes (as defined in sub-
17 section (yy)(2)),” in the matter preceding clause (i);
18 and

19 (2) in subsection (yy)—

20 (A) in the heading, by adding “; Pre-Dia-
21 betes” at the end; and

22 (B) by adding at the end the following new
23 paragraph:

24 “(4) The term ‘pre-diabetes’ means a condition of im-
25 paired fasting glucose or impaired glucose tolerance identi-

1 fied by a blood glucose level that is higher than normal,
2 but not so high as to indicate actual diabetes.”.

3 (b) EFFECTIVE DATE.—The amendments made by
4 this section shall apply with respect to services furnished
5 on or after January 1, 2019.
