Ms. VELÁZQUEZ (for herself, Mr. ELLISON, Ms. JAYAPAL, Mr. DEFazio, Ms. SHEA-PORTER, Mrs. CAROLYN B. MALONEY of New York, and Mrs. WATSON COLEMAN) introduced the following bill; which was referred to the Committee on Agriculture, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

A BILL

To cancel the registration of all uses of the pesticide chlorpyrifos, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Pesticide Protection
5 Act of 2017”.

1 **SEC. 2. CANCELLATION OF REGISTRATION OF**
2 **CHLORPYRIFOS.**

3 (a) IN GENERAL.—Pursuant to section 6(b) of the
4 Federal Insecticide, Fungicide, and Rodenticide Act (7
5 U.S.C. 136d(b)), effective on the date of the enactment
6 of this Act—

7 (1) chlorpyrifos shall be deemed to generally
8 cause unreasonable adverse effects on the environ-
9 ment due in part to dietary risks to humans posed
10 by residues of that pesticide chemical on food;

11 (2) the Administrator of the Environmental
12 Protection Agency shall cancel the registration of all
13 uses of chlorpyrifos; and

14 (3) following such cancellation the Adminis-
15 trator shall, in accordance with section 408(l)(2) of
16 the Federal Food, Drug, and Cosmetic Act (21
17 U.S.C. 346a(l)(2)) revoke any tolerance or exemp-
18 tion that allows the presence of chlorpyrifos or any
19 pesticide chemical residue that results from its use,
20 in or on food.

21 (b) USE OF EXISTING STOCKS.—Notwithstanding
22 section 6(a) of the Federal Insecticide, Fungicide, and
23 Rodenticide Act (7 U.S.C. 136d(a)), effective on the date
24 of the enactment of this Act, the continued sale and use
25 of existing stocks of chlorpyrifos is prohibited.

1 (c) REREGISTRATION.—Effective on the date of the
2 enactment of this Act, the Administrator of the Environ-
3 mental Protection Agency may not reregister chlorpyrifos
4 under section 4 of the Federal Insecticide, Fungicide, and
5 Rodenticide Act (7 U.S.C. 136a–1).
