Mrs. NOEM introduced the following bill; which was referred to the Committee on Ways and Means

A BILL

To prevent States from counting certain expenditures as State spending to reduce TANF work requirements.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “TANF Accountability
5 and Integrity Improvement Act”.

6 **SEC. 2. NO COUNTING OF THIRD-PARTY SPENDING TO**
7 **MEET STATE SPENDING REQUIREMENT.**

8 (a) EXCLUSION OF THIRD-PARTY CONTRIBU-
9 TIONS.—Section 409(a)(7)(B)(i) of the Social Security

1 Act (42 U.S.C. 609(a)(7)(B)(i)) is amended by adding at
2 the end the following:

3 “(VI) EXCLUSION OF THIRD-
4 PARTY CONTRIBUTIONS.—Such term
5 shall not include—

6 “(aa) for fiscal year 2018,
7 the amount (if any) by which—

8 “(AA) the value of all
9 goods and services provided
10 by a source other than the
11 State or a local government
12 during the fiscal year; ex-
13 ceeds

14 “(BB) the value of all
15 such goods and services
16 claimed by the State as
17 qualified State expenditures
18 for fiscal year 2017;

19 “(bb) for fiscal year 2019,
20 the amount (if any) by which—

21 “(AA) the value re-
22 ferred to in subclause
23 (aa)(AA); exceeds

1 “(BB) 50 percent of
 2 the value referred to in sub-
 3 clause (aa)(BB); and
 4 “(cc) for any fiscal year
 5 after 2019, the value referred to
 6 in subclause (aa)(AA).”.

7 (b) EXCLUSION OF EXPENDITURES FOR THE PROVI-
 8 SION OF MEDICAL SERVICES.—Section 409(a)(7)(B)(i) of
 9 such Act (42 U.S.C. 609(a)(7)(B)(i)), as amended by sub-
 10 section (a) of this section, is amended by adding at the
 11 end the following:

12 “(VII) EXCLUSION OF EXPENDI-
 13 TURES FOR THE PROVISION OF MED-
 14 ICAL SERVICES.—Such term shall not
 15 include any amount expended for the
 16 provision of medical services.”.

17 **SEC. 3. EFFECTIVE DATE.**

18 The amendments made by this Act shall take effect
 19 on October 1, 2017.
