Mr. CLEAVER (for himself and Mr. YODER) introduced the following bill;
which was referred to the Committee on Education and the Workforce

A BILL

To amend the Elementary and Secondary Education Act of 1965 to require that teachers, principals, counselors, and other school leaders receive youth suicide awareness and prevention training.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Cady Housh and Jason
5 Flatt Teen Suicide Prevention Act of 2017”.

6 **SEC. 2. FINDINGS.**

7 Congress finds the following:

1 (1) Since 2010, suicide has been the second
2 leading cause of death for young people ages 10–24
3 with more than 100 young people lost each week.

4 (2) According to the 2013 Centers for Disease
5 Control and Prevention Youth Risk Behaviors Sur-
6 vey, 17 percent of high school students reported seri-
7 ously considering suicide during the last year of high
8 school and about 8 percent of high school students
9 attempt suicide during that period.

10 (3) 80 percent of students show warning signs
11 before attempting suicide.

12 **SEC. 3. SUICIDE AWARENESS AND PREVENTION TRAINING.**

13 (a) IN GENERAL.—Subpart 2 of part F of title VIII
14 of the Elementary and Secondary Education Act of 1965
15 (20 U.S.C. 7901 et seq.) is amended by adding at the end
16 the following:

17 **“SEC. 8549D. SUICIDE AWARENESS AND PREVENTION**
18 **TRAINING.**

19 “(a) IN GENERAL.—Each State receiving funds
20 under this Act shall establish and implement a statewide
21 policy that school leaders, counselors, teachers, para-
22 professionals, and other staff shall complete at least one
23 hour of youth suicide awareness and prevention training
24 each school year.

1 “(b) YOUTH SUICIDE AWARENESS AND PREVENTION
2 TRAINING DEFINED.—In this section, the term ‘youth sui-
3 cide awareness and prevention training’ includes self or
4 in-person review of materials—

5 “(1) the State determines appropriate; and

6 “(2) that include—

7 “(A) the warning signs of, and elevate risk
8 factors for, suicide;

9 “(B) suggested responses to such warning
10 signs; and

11 “(C) further suicide awareness and preven-
12 tion resources.

13 “(c) RULE OF CONSTRUCTION.—Nothing in this sec-
14 tion shall be construed to preempt any State law to the
15 extent that such State law imposes a more extensive re-
16 quirement for youth suicide awareness and prevention
17 training in such State.”.

18 (b) SENSE OF CONGRESS.—It is the sense of Con-
19 gress that—

20 (1) youth suicide awareness and prevention
21 training materials should be available to all school
22 teachers, principals, and other school leaders;

23 (2) each local educational agency should adopt
24 a policy with respect to youth suicide awareness and
25 prevention; and

1 (3) the Secretary of Education should collabo-
2 rate with the Secretary of Health and Human Serv-
3 ices to publically display and distribute information
4 and resources on teen suicide prevention.
