AN ACT

- To establish a working group to determine ways to develop a domestic canine breeding network to produce high quality explosives detection canines, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "Domestic Explosives3 Detection Canine Capacity Building Act of 2017".

4 SEC. 2. DEFINITIONS.

5 In this Act:

6 (1) BEHAVIORAL STANDARDS.—The term "behavioral standards" means standards for the evalua-7 8 tion of explosives detection working canines for cer-9 tain factors, including canine temperament, work 10 drive, suitability for training, environmental factors 11 used in evaluations, and canine familiarity with natural or man-made surfaces or working conditions 12 13 relevant to the canine's expected work area.

14 (2) MEDICAL STANDARDS.—The term "medical
15 standards" means standards for the evaluation of
16 explosives detection working canines for certain fac17 tors, including canine health, management of hered18 ity health conditions, breeding practices, genetics,
19 pedigree, and long-term health tracking.

20 (3) TECHNICAL STANDARDS.—The term "tech21 nical standards" means standards for the evaluation
22 of explosives detection working canines for certain
23 factors, including canine search techniques, handler24 canine communication, detection testing conditions
25 and logistics, and learned explosive odor libraries.

1 SEC. 3. DOMESTIC CAPACITY DEVELOPMENT.

2 (a) IN GENERAL.—Not later than 90 days after the 3 date of the enactment of this Act, the Secretary of Homeland Security, acting through the Administrator of the 4 5 Transportation Security Administration, shall establish a working group to determine ways to develop a decentral-6 7 ized domestic canine breeding network to produce high 8 quality explosives detection canines and modernize canine training standards. 9

(b) WORKING GROUP COMPOSITION.—The working
group established under subsection (a) shall be comprised
of representatives from the following:

13 (1) The Transportation Security Administra-14 tion.

15 (2) The Science and Technology Directorate of16 the Department of Homeland Security.

17 (3) National domestic canine associations with18 expertise in breeding and pedigree.

(4) Universities with expertise related to explo-sives detection canines and canine breeding.

21 (5) Domestic canine breeders and vendors.

(c) CHAIRPERSONS.—The Administrator for the
Transportation Security Administration shall approve of
two individuals from among the representatives of the
working group specified in subsection (b) to serve as the
Chairpersons of the working group. One such Chairperson

shall be from the entities specified in paragraphs (1) and
 (2) of such subsection, and the other such Chairperson
 shall be from the entities specified in paragraphs (3), (4),
 and (5) of such subsection.

5 (d) Preliminary Standards and Recommenda-TIONS.—Not later than 180 days after the establishment 6 7 of the working group under subsection (a), such working 8 group shall submit to the Administrator of the Transpor-9 tation Security Administration preliminary behavioral 10 standards, medical standards, and technical standards for the domestic canine breeding network and canine training 11 12 described in such subsection, including recommendations 13 on how the Transportation Security Administration can engage stakeholders to further the development of such 14 15 network and training.

(e) STRATEGY.—Not later than 180 days after sub-16 mission of recommendations to the Administrator of the 17 18 Transportation Security Administration under subsection 19 (c), the Administrator shall submit to the Committee on Homeland Security of the House of Representatives and 2021 the Committee on Commerce, Science, and Transportation 22 of the Senate a strategy for expanding the domestic canine 23 breeding network described in subsection (a), based on 24 such recommendations.

1 (f) CONSULTATION.—In developing the strategy re-2 quired under subsection (e), the Administrator of the 3 Transportation Security Administration shall consult with 4 the Under Secretary for Science and Technology of the 5 Department of Homeland Security, the Commissioner for U.S. Customs and Border Protection, the Director of the 6 7 United States Secret Service, and the heads of other De-8 partment of Homeland Security components determined 9 appropriate by the Administrator to incorporate, to the ex-10 tent practicable, mission needs across the Department for an expanded domestic explosives detection canine breeding 11 network that can be leveraged to help meet the Depart-12 13 ment's operational needs.

(g) SUNSET.—The working group established under
subsection (a) shall terminate on the date that is 2 years
after the submission of the strategy required under subsection (e).

18 SEC. 4. ACQUIRING BASELINE CAPACITY.

(a) IN GENERAL.—Not later than 270 days after the
submission of recommendations to the Administrator of
the Transportation Security Administration under section
3, the Administrator shall issue baseline behavioral standards, medical standards, and technical standards for explosives detection canines.

(b) STANDARDS.—The baseline behavioral standards, 1 2 medical standards, and technical standards referred to in subsection (a) shall be incorporated, as appropriate, into 3 4 all statements of work for the Transportation Security Ad-5 ministration explosives detection canine contracts and reflect the detection capabilities required to effectively miti-6 7 gate terrorist threats. Such standards may be revised by the Administrator of the Transportation Security Admin-8 9 istration, as necessary.

10 SEC. 5. NONAPPLICABILITY OF FEDERAL ADVISORY COM11 MITTEE ACT.

12 The Federal Advisory Committee Act (5 U.S.C. App.)13 shall not apply to the working group established under this14 Act.
