A BILL

To amend title 38, United States Code, to establish the office of the Health Monitor of the Department of Veterans Affairs, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Fixing VHA Facilities
- 5 Act".
- 6 SEC. 2. HEALTH MONITOR.
- 7 (a) In General.—Chapter 3 of title 38, United
- 8 States Code, is amended by inserting after section 312A
- 9 the following new section:

1 "§ 312B. Health Monitor.

- 2 "(a) IN GENERAL.—(1) There is in the Department
- 3 a Health Monitor who shall appointed by the Secretary.
- 4 "(2) The Health Monitor shall report to the Inspector
- 5 General in the discharge of the duties of the Health Mon-
- 6 itor under subsection (c). The Inspector General may not
- 7 terminate the Health Monitor until 60 days after the date
- 8 the Inspector General notifies Congress of such impending
- 9 termination.
- 10 "(3) In discharging the duties under subsection (c),
- 11 the Health Monitor shall have the powers of an Inspector
- 12 General under section 6 of the Inspector General Act of
- 13 1978 (5 U.S.C. App.).
- 14 "(b) QUALIFICATIONS.—Each individual appointed
- 15 as Health Monitor shall be an individual who has sub-
- 16 stantive professional experience in at least one of the fol-
- 17 lowing areas:
- 18 "(1) Federal oversight.
- 19 "(2) Health care administration.
- 20 "(3) Health care delivery.
- 21 "(4) Patient advocacy.
- 22 "(c) Duties.—(1) Not later than 60 days after the
- 23 issuance of the end-of-year relative performance star rat-
- 24 ings (in this section referred to as 'Star Ratings') for each
- 25 fiscal year, the Health Monitor shall identify and transmit
- 26 a list of specific improvement recommendations for each

- 1 medical center of the Department that received fewer than
- 2 three stars in the Star Ratings for the most recent fiscal
- 3 year. The Health Monitor shall transmit each such list
- 4 to—
- 5 "(A) the Director of the medical center named
- 6 in the list;
- 7 "(B) the Secretary;
- 8 "(C) the Committees on Veterans' Affairs of
- 9 the Senate and the House of Representatives;
- 10 "(D) the Senators for the State in which the
- 11 medical center is located; and
- 12 "(E) the Representative in whose congressional
- district the medical center is located.
- 14 "(2) Not later than 180 days after the Health Mon-
- 15 itor transmits a list under paragraph (1), the Health Mon-
- 16 itor shall submit a report to the recipients of that list a
- 17 report that identifies—
- 18 "(A) the extent to which the Director of the
- medical center implemented the plan;
- 20 "(B) any change in the performance of the
- 21 medical center.".
- 22 (b) CLERICAL AMENDMENT.—The table of sections
- 23 at the beginning of such chapter is amended by inserting

- 1 after the item relating to section 312A the following new
- 2 item:

"312B. Health Monitor.".
