Ms. TENNEY (for herself, Mr. BERGMAN, Mr. HOLLINGSWORTH, and Mr. BUDD) introduced the following bill; which was referred to the Committee on House Administration, and in addition to the Committee on Oversight and Government Reform, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

### A BILL

- To prohibit the pay of Members of Congress during periods in which a Government shutdown is in effect, and for other purposes.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,

#### **3** SECTION 1. SHORT TITLE.

4 This Act may be cited as the "No Work, No Pay Act5 of 2018".

# 1SEC. 2. PROHIBITING PAY OF MEMBERS OF CONGRESS IN2RESPONSE TO GOVERNMENT SHUTDOWN.

3 (a) PROHIBITION OF PAY.—If on any day during a
4 pay period a Government shutdown is in effect, the payroll
5 administrator of each House of Congress shall exclude
6 from the payments otherwise required to be made with re7 spect to that pay period for the compensation of each
8 Member of Congress who serves in that House of Congress
9 an amount equal to the product of—

(1) an amount equal to one day's worth of pay
under the annual rate of pay applicable to the Member under section 601(a) of the Legislative Reorganization Act of 1946 (2 U.S.C. 4501); and

14 (2) the number of 24-hour periods during which
15 the Government shutdown is in effect which occur
16 during the pay period.

(b) ROLE OF SECRETARY OF THE TREASURY.—The
Secretary of the Treasury shall provide the payroll administrators of the Houses of Congress with such assistance
as may be necessary to enable the payroll administrators
to carry out this section.

(c) PAYROLL ADMINISTRATOR DEFINED.—In this
section, the "payroll administrator" of a House of Congress means—

Representatives, or an employee of the Office of the
 Chief Administrative Officer who is designated by
 the Chief Administrative Officer to carry out this
 section; and

5 (2) in the case of the Senate, the Secretary of
6 the Senate, or an employee of the Office of the Sec7 retary of the Senate who is designated by the Sec8 retary to carry out this section.

9 (d) EFFECTIVE DATE.—This section shall apply with
10 respect to days occurring during the One Hundred Six11 teenth Congress and each succeeding Congress.

#### 12 SEC. 3. DETERMINATION OF GOVERNMENT SHUTDOWN.

For purposes of this Act, a Government shutdown shall be considered to be in effect if there is a lapse in appropriations for any Federal agency or department as a result of a failure to enact a regular appropriations bill or continuing resolution.

#### 18 SEC. 4. MEMBER OF CONGRESS DEFINED.

In this Act, the term "Member of Congress" means
an individual serving in a position under subparagraph
(A), (B), or (C) of section 601(a) of the Legislative Reorganization Act of 1946 (2 U.S.C. 4501).
